JONES' CASE CALLED THIS MORNING 9:30

INDICTED FOR KILLING DR. L. O. McCALLA AT STARR

PROMINENT CASE

Smith, Bonham, Pearman, State —Watkins & Prince, Bonham, Watkins & Allen, Defense.

Feaster Jones, indicted on the charge of murder, will be arraigned and placed on trial this morning at 9:30 o'clock, when court reconvenes for the day.

It will be recalled that Jones is charged with shooting and killing Dr. Lawrence O. McCalla in his garage at Starr a few weeks ago. This affair is too well remembered to go into details.

Owing to the prominence of both parties, this case will attract more attention than any case that has been called in recent years in Anderson. At the time of the killing the cause for the act appeared to be a mystery. Since that time it has developed that it was over domestic troubles.

It was announced yesterday from a reliable source that Solicitor K. P. Smith would be assisted in the prosecution by Solicitor Proctor A. Bonham of Greenville and Mr. Dean Pearman of this city. For the defense there will be Messrs. Watkins & Prince and Messrs. Bonham, Watkins & Allen.

In Rather Bad Shape and Anderson Stands Next to Bottom List in South Carolina.

The meeting of the South Carolina Fire Insurance Association in Anderson yesterday was very satisfactory. 16 special agents representing insurance companies doing business in this state being present. Yesterday morning was spent in inspecting buildings and premises. Yesterday afternoon the agents met with the mayor, members of city council, the chief of police, chief of the fire department, and insurance men of the city in the city hall to discuss conditions in Anderson.

"The meeting of the association has been very satisfactory from every standpoint," stated Mr. R. H. McDowell, representing the Yorkshire Fire Insurance company yesterday afternoon. "The reception this afternoon by the mayor and the city council was very cordial and we are well pleased. We found conditions here in Anderson in bad shape and there is plenty need of remedies, especially in the way small quantities of gasoline is allowed to be kept and handled by irresponsible parties. Five years ago Anderson stood at the head of the cities in South Carolina in having the fewest fires, but now she stands next to the bottom, Columbia being the last on the list."

SLOW GRIND IN COURT DURING YESTERDAY

LABOON MURDER CASE IN HANDS OF JURY EN-TIRE DAY

NO VERDICT YET

Jury Was Still In Their Room Yesterday Afternoon and Appeared Hopelessly Tied Up.

Most of yesterday in the court of general sessions was taken up with the hearing of minor cases. The jury in the case of Henry and Walter Laboon, charged with murder, was charged by Judge Moore yesterday morning and retired to their room. When court took a recess yesterday afternoon at 6 o'clock, a verdict had not been reached. It seems that this case will receive the same fate that it did at the last term, a mistrial.

Jesse Cochran, indicted for assault and battery with intent to kill and carrying concealed weapons, was tried in his absence. The verdict of the court was that he be confined at hard labor for a period of four months or pay a fine of \$150.

Peter Broyles entered a plea of guilty on a charge of larceny and was sentenced to four months. John Shaw and Jim Jones, indicted on the same charge, were tried and found not guilty.

Sam Griffin also entered a plea of guilty on an indictment of larceny. He received a sentence of twelve months, four of which are to be served, the other to be suspended during good behavior.

The grand jury returned the following bill:

Joseph Senborn, violation dispensary law, true bill. All of the minor cases having been tried, and those indicted on the charge of murder claiming the three days after court convenes allowed by law, the work in court yesterday was somewhat hindered. The Jones case will be called this morning.

Mistrial Ordered. Last night about 10 o'clock Judge Moore was called to the court room to receive the verdict of the jury on the Laboon murder case. The foreman announced that an agreement could not be reached, and a mistrial was ordered. It is said that there were eight for acquittal and four for a verdict of manslaughter with recommendation to mercy of the court.

NEW OFFICIALS FOR C. & W. C. RAILWAY

The following from the Greenwood Journal will be read with interest here:

The Daily Journal received a telegram this morning from Mr. A. F. McKissick in Charleston announcing the election of Mr. F. Barron Grier as president of the Charleston and Western Carolina railway as successor to Mr. John B. Cleveland of Spartanburg, resigned. Mr. Grier's appointment to this highest position of the C. & W. C. system was made at a meeting of the directors in Charleston. No intimation had been given of the resignation of Mr. Grier for a number of years and the news Cleveland, who has held the position was not expected in Greenwood, though Mr. Grier's friends are not surprised that he has been thus honored by the railway authorities.

Mr. Grier has been general solicitor of the Charleston & Western Carolina for the past two years and served in the capacity of local counsel for several years.

A. W. Anderson, general manager was also made vice-president.
