To assist the plant engineers in areas of electrical equipment, refrigeration, compressed air, boilers, fire protection and air conditioning, a computerized reminder and instruction system has been installed to keep track of quarterly, semi-annual and annual maintenance procedures.

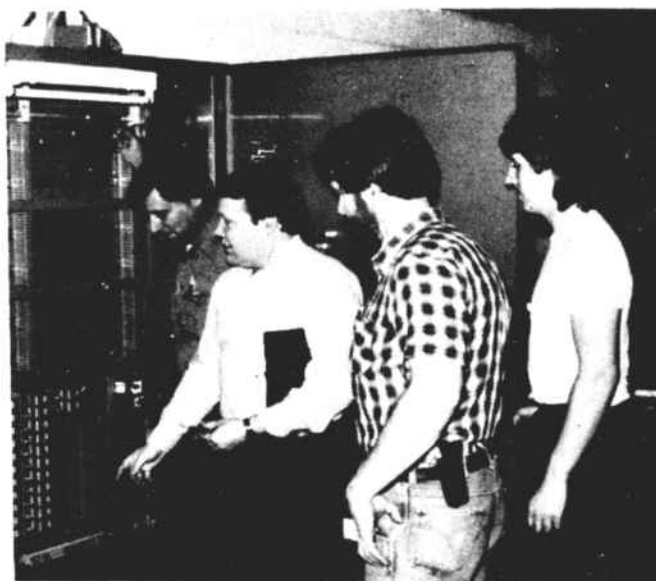
