The State of South Carolina, CITY OF GREENVILLE. An Ordinance to Raise Supplies for 1879.

Sec. 2. There shall be paid, quarterly, One Per Cent. upon all Sales at Auction, on all Goods and Chattels, and Real Estate, and on all other descriptions, except on sales made by order of Court or process of law...

Sec. 3. There shall be paid by all Merchants, or others, One-Half Per Cent. upon all Receipts of each and every Export Company transacting business within the limits of the City...

Sec. 4. That each and every male person between the ages of eighteen and fifty years, Ordained Minister, and Student, shall pay, on or before the first day of March next...
