### Working the Roads

The Augusta road, over which more travel is made than any other stretch of road in the county, is now being put in order by Capt. Charlie Meetze, who with the assistance of a squad of convicts from the chain gang, mules and a road machine, is shaping the road-bed and filling in the broken places. Capt. Meetze is now working between Lexington and the Hamburg branch, but will work on to Brookland. This is the right thing to do and the right man to do the work. Charlie has had experience and knows the work. Capt. M. L. Corley has the chain gang in the Fork and from advices received from many sources is doing considerable substantial work with the new road machine. The new machine is propelled by gasoline and appears to work wonderful feats in road building, what we have long needed. Let the good work go on.

### Meeting of County Board.

The County Board of Commissioners were in session Monday, Supervisor Corley, Commissioners Addy and Smith, all present. Clerk J. B. Wingard had the clerical work in readiness for the board's consideration. The following Magistrates of the county were present and made their reports as previously called for by the board; Col. J. H. Frick, Chapin; Mr. W. E. Loric, Irmo; Henry Buff, Brookland; Thos. L. Harman, Lexington; J. W. Roof, Pelion; Gus Bleese, Batesburg; Ioor Hayes, Gilbert; U. W. Jefcoat, Swansea. The returns were satisfactory and our county's magistrates made a good showing. The amount of fines turned over by each will be seen elsewhere in a statement handed to us by Auditor Dent.

### J. N. Fowles Dead.

J. Newton Fowles, well known lumber dealer, farmer and Confederate veteran, died Monday morning at his residence in Columbia, at the age of 72 years. Mr. Fowles was well known to our people, he having resided in the Blackcreek section, of this county, at what is now Azariah Taylor's mill, from there he conducted a lumber and turpentine business on an extensive scale. He was born in Walterboro. He married a daughter of Chancellor Job Johnstone of Newberry and is survived by his wife and two children, James H. Jr. and Frances J. Fowles, and a brother Jas. H. Fowles, of Birmingham, Ala. The funeral was held Tuesday at Newberry.

### New Gin for Lexington.

It will be of interest to the farmers around Lexington to learn that the Lexington Cotton Mill has purchased one of the best gin outfits on the market, a three \$0 saw huller box Gullett ginning system, up-to-date in every particular.

Mr. G. S. Wright is here to install and operate the gin. It will be located at the mill, about 150 feet east of the boilers, and will be in readiness for the first of the season.

This outfit will have a capacity of about 40 bales per day and we understand it is proposed to gin at a price that will be very attractive to the farmers.

The market price will be paid for cotton and seed at the gin. Arrangements are also being made whereby the farmer may store his cotton in a bonded warehouse. Receipts for cotton stored in a bonded warehouse is gilt edge security for loans. This will be quite an advantage to any one wishing to hold cotton and borrow money against same, and to hold for better prices. We are glad to have these much needed additions to our town.

The magistrate's decision was favorable to Mr. Hutto, while pending appeal from this decision to the higher court the custody of the children was divided. Mr. Sharpe represented Mrs. Goodwin, while Messrs. Pringle Youmans and DePass appeared for Mr. Hutto.

### Gonzales Confirmed.

Last week we mentioned the nomination of Capt. W. E. Gonzales, editor of The State, to be Minister to Cuba. The Senate has confirmed his nomination which of course was no more than to be expected, for it rarely occurs that confirmation by the Senate does not follow nomination by the President and especially so is the case when congress and the president are of the same political party. President Wilson could not have made a better selection.

Mr. Gonzales has done as much for the Democratic party as any one man we know. Such an appointment was due W. E. Gonzales. Being fitted in every way he will render valuable service both to Cuba and our own country.
