The Romans are determined to resist the threatened attack to the death, and have raised an Army of eighty thousand.

The Roman leaders declare they will blow up St. Peter's and all the Church Edifices, if they should be unable to re-pulse the French.

HUNGARY.

Hungarian affairs present no new fea-tures since the fall of Buds, and no event has occurred calculated to have an effect on the result of the struggle, though the Hungarians have gained several new and important victories. Both parties are concentrating their respective forces for a decisive struggle, and the great battle was daily expected.

FRANCE.

The message of the French President to the New Assembly, fills four colums

of the large English papers.

A new Cabinet had been formed by a compromise between Odillon, Barrot, and Dufaure. The only change in the Cabinet is Dufaure. De Tocqueville and Laquinau, take posts in it. M. Bugeaud has been dismissed.

GERMANY. At Frenkfort, the Parliament are forming a Government on the model of that of the French Republic.

"That which we call a rose,
"That which we call a rose,
By any other name would smell as sweet,
So slavery would, were it not slavery called,
Retain the gentle chantres it owes
without that title.
"It is acknowledged then, that poverty
and privation are the inheritance of all
the serving classes in the goods the

the serving classes in the world—the American slave alone excepted. Then why, I would solemnly ask of you, vain glorious, hollow, and pretended advocates of liberty, who, in the name of that remnant of contented bondsmen, why do you perplex yourselves and them? For Heav-en's fair sake leave these negroes, the few remaining happy laborers who yet exist, to eat the bread of peace, and to dance and sing in the groves which they have planted."

Overland Emigration to California.— We have been favored with the following extract of a letter received from Captain Stewart Van Vleit, of the U.S. Army, dated at "Fort Kearny, Nebraska Territory," (220 miles west of Fort Leaven-worth, Missouri,) on the 21st of May:

"On the 6th instant the first party bound for California passed this post, and since that date a constant stream of emigration has been setting in that direction. Up to the present time 1,203 wagons have gone by; on an average there are four men and eight to ten animals to a wagon. This is but the beginning. Over five thousand teagons and twenty-five thousand sand men will attempt to reach Califor-nia this season by this route."

A postscript to the same letter, dated May 22d, says, "Yesterday 232 wagons passed, making 1,435 in all."
