Of the fountains on the lawn, Where mellow sunbeams flood the way Of the bounding spotted fawn.


Tall, graceful pines are bending low

#### Official Copy of the Act Relative to the Fencing of Stock in Oconee County.

AN ACT to amend an Act entitled "An Act to amend an Act entitled an Act to protect the Lands and Crops of the Citizens of Abbeville, Union, Newberry and Laurens Counties from Trespass by Stock, and make the same apply deceased, amongst his heirs at law. to Spartanburg County and a portion of the County of Coonce," approved December 23d. 1870, so as to extend the Provisions of said Act to Portion of Oconee County, without Submitting the Question of its Adoption to the Voters living in said Territory.

SECTION 1. Be it enacted by the Senate and House of Representatives of the State of South Carolina, now met and sitting in General Assembly, and by the authority of the same, That Section 4 of said Act so far as it relates to Ocones County, be amended by striking out in the first line thereof the words "first day of January" and insert in lieu thereof the words "first day of March."

SEC. 2. That Section 5 of said Act be amended by striking out all of said Section after the words "as live," in the second line thereof and inserting in lieu thereof the following words: South of a line beginning at a point on the West side of the Keowee River, in said county, opposite where the line fence in Pickens County comes to said river, running the most practicable COTHRAN & STRIBLING, line to Hall's Muster Ground, thence to Poplar Spring Church in Oconce County, thence the most direct practicable line & Jarrett's Ferry on the Tugaloo River, including O. M. Doyle's farm, to be determined and located by the County Commissioners of said county: Provided, That Company shall pay to the construction of the line fence across said county the sum of fifty Gollars por mile for as many miles as there are miles of said railroad in said county: Provided further, That no tax shall be levied upon any property in said county North of the line herein designated for the purpose of building or maintaining said fence."

Sec. 3. That it shall not be lawful for any person or persons to drive cattle from below said line North thereof for purposes of herding and grazing the same between the first day of Februory and the 15th day of October in any year, Any violation of this Section shall be deemed a misdemeanor and any person or persons convisted thereof shall be fined in a sum not exseeding fifty dollars or imprisoned in the county jail for a period not exceeding thirty days,

SEC. 4. That all Acts and parts inconsistent with this Act, so far as the same relates to Oconce county, be, and the same are hereby;


