Associate Justice Cothran wrote the opinion and the entire court concurred, the new trial being granted on the grounds that Gossett was not given a fair trial by the special court. Justice Cothran severely criticises the statute under which special courts are called, and cites a number of incidents to show that an his plea for a new trial. accused has no showing under the present policy of special courts.

The court also severely criticises the spirit of mobs, and says that where trials are held under conditions similar to those obtaining at trial, and concluded that he had not. the Gossett case, it is a "judicial lynching." The Abbeville court was called to try the Gossetts alone.

The opinion affects a number of other special courts held recently, and virtually says that these courts could not give a defendant a fair trial. Several trials by special courts, it is recalled, have resulted in electrocutions, and "Ping" Griffin is now in the penitentiary under death sentence by a verdict of a jury called together especially to try him, and the circumstances are a good deal similar to the Gossett case. No appeal has been taken in the Griffin case, and "Feetie" Fogle has already been electrocuted by a special court

Speaks of Mob Violence.

Speaking of mob violence and the effect on the public mind in trials like Gossett's, and the section under which the court was called, Justice Cothran says: "We are convinced that the procedure provided for in the spirit of mob law, and presents the spectacle of the law, strong and how delighted I am that I am going. mighty, bowing to the despotism of the mob, which has been declared to be greater than the tyranny of a despot. It provides a miserable compromise with lynch law, enabling the law to bargain with the mob to stay its hand and allow the court, under the form of law, to accomplish what is equally reprehensible—a judicial lynching.

"It is notorious that such bargainings have been made. The angry mob has been appeased by the promise of a quick special court to try the offender under circumstances that render his conviction inevitable.

"There can be no compromise with the spirit of lynching for any crime. Those who compose such a mob are themselves without the pale of law and commit a crime not only against against the majesty of the law. They are not entitled to recognition as

U. S. Will Lose a Million.

Washington, Aug. 26 .- The United States will lose a million dollars by reason of the destruction of the dirigible ZR-2 under terms of an agreement entered into with the British government. The agreement, according to a statement issued to-day by the navy department, "provided that in the event of total loss of this airship (the ZR-2) while under construction or during trials, the two governments would jointly bear the

The United States has paid \$1,500,-000 to the British government on contract cost of \$2,000,000 for the ZR-2, the statement added. Accordingly the British government will turn back to the United States the sum of \$500,000.
