SALE OF LANDS

For Unpaid DIRECT TAXES in Insurrectionary Districts.

State of South Carolina.

Notice is hereby given that the several Tracts or Lots of Land situated in the State of South Carolina, hereinafter described, have become forfeited to the United States by reason of the non-payment of the direct taxes charged thereon under the act entitled, "An act to provide increased revenue from imports to pay interest on the public debt and for other purposes," approved August 5, 1861, and an act entitled, "An act for the collection of direct taxes in insurrectionary districts within the United States, and for other purposes," approved June 7, 1862, and that the same will be sold at public auction on the 11th day of February, A. D., 1868, at 10 o'clock A. M. of said day, at the office of the Direct Tax Commissioners under said Acts for the State of South Carolina, in the Town of Beaufort in the Parish of St. Helena, Beaufort District and State aforesaid; and that the sale of the same will be continued from day to day until all of said Lots and Tracts of Land are finally disposed of.

The following is a description of said lands forfeited as aforesaid, together with the amount of the quota of said tax and penalty charged upon each of said tracts or lots of land, respectively:
