Gov. Hamilton has issued a Proclamation, ordering the necessary steps to enable him to call a convention of delegates to be elected by those of the people who are loyal to the United States, and none other.

The Chief-Justice of each county, Clerk of County Court, and Clerk of the District Court, are to sit as a Board of Administration, to make, a list of those who have never participated in the rebellion, but have always been loyal; then of those who desire to take the amnesty oath in order to vote; and then of those who are in the "excepted" class, and take the oath simply as a preliminary to apply for pardon.

This County Board is to sit at least one day, and if necessary two or three days, in each week—due public notice being given of the same.

The Chief-Justice, whenever he deems proper, will have the power to swear the applicant for the amnesty oath, to answer guestions as to his loyalty to the United States Government, and his increase in taking the oath. Should the applicant refuse to be sworn, or, being sworn, shall, in his answers, give evidence of hostility to the Government, or of a purpose to oppose the measures that have been adopted relative to abolishing slavery, it would be the duty of the board to refuse to administer the oath.

A number of citizens, Dr. Thomas Moore, John Moore, Wm. Harris, J. A. Pankey, C. Dorbandt and Mr. Need, from Eurnet County, Sam Tate and W. E. Wooten, from Eurnet County, and C. Ake, Wm. Ake and James O. Rice, from Williamson County, have been arrested, brought to Austin and put in jail. Charges not known.

In Goliad County one Frazier heads an organized band of desperadoes, who have committed robberies on a large scale, and bid open defiance to law. They lately captured a train of wagons laden with merchandise valued at \$30,000; took the goods to Goliad, put them in store, and sold in open day by the robbers.

The Austin Intelligencer says the Indians have come down to within thirty miles of that city. They have murdered several families higher up the country. On the head of Spring Creek, in Gillespie County, they killed two men, three women and four children, scalping all of them.

THE FRENCH RECLAMATION—ANOTHER LAPORTANT TELEGRAPH LINE SECURED TO NEW YOUR CAPITAL-ISTS—FORCED LOANS AND ROBBERIES BY THE JUARIST FORCES.

The latest advices from Mexico, by way of Vera Cruz and Havana, include several items of in-

The Imperial Government has decided that the French reclamations shall be arranged as soon as possible, and on the most equitable terms.

The Mexican papers, on the Imperial side, contain many accounts of alleged forced loans and robberies by the Jusrist forces.

The Emperor has conceded to Mr. Charles J. Arnoux, who represents various New York capitalists, the privilege of building telegraph lines, which will connect Toluca, Morelia, Zamora, Barca, Guadalajara, Topic, San Blas, Mazatlan, Culiacan and Guaymas with San Francisco. Another reaching from Mazatlan to Durango, Cueucame, Parra, Villa Aldamas, Cerralvo and Camargo, and another from Manzanillo to the city of Guadalajara.

The troops under Capt. Ney have left Monterey for Cadereita, their object being to destroy several bands of partisans yet existing in that portion of the Department adjoining to Tamaulipas.

There exists not the least doubt that the pacification of the Department of Nueva Leon will soon be fully restored by the energy and activity displayed by Col. Jenningros, and the hearty co-operation of the Prefect.

The French authorities have issued orders for repairing the fortifications situated around the city, and the construction of others. Once completed, these fortifications will remove all apprehensions that the city will ever again be taken possession of by the enemy.

Gen. Brincourt was, according to the latest dates, at Monclava, and the Commandant Delloye at Matchucla. Two hundred and fifty Chasseurs d'Afrique had arrived at San Luis. It was asserted that the enemy would make efforts to effect their escape to Tamaulipas by way of Miquisguano, Tancanhuitz or Huasceta.

I hear from authoritative sources that the radicals are arming their batteries heavily for the great contest they are determined to wage at the next session of Congress. President Johnson, they assert, is not carrying out the principles upon which he was elected, and it is the determination of these gentlemen that no other principles shall govern if they can help it. One of the most radical of the old Senators has even gone so far as to declare his intention of offering a bill of impeachment soon after the meeting of Congress, and advocating it with all his accustomed energy and determination. The President, it is well known, is not unmindful of the fanatical war-cloud that is rising, but he has cast his anchors upon a sure bottom, and no apprehension need be felt for the safety of either ship or pilot.

THE BOOK TRADE SALE IN NEW YORK.—The Book Trade sale was continued on Friday morning, before a large attendance. The great invoice of Appleton, which was diminished Thursday night, brought \$30,000. The prices generally realized were about the same as those of the previous season. Books published at \$1 to \$1.50 were engerly purchased at from 50 to 75 cents each. But the standard works brought higher prices. Appleton's Galleries, published at \$15, were sold at \$11; Buckle's History of Civilization sold at \$2 to \$2.25 a volume; Gen. Dix's Life and Speeches were bid up to \$1 per volume. Among the books sold were six copies of Bryant's Works; fifty of Dana's Household Book of Poetry; twenty of Burton's Cyclopedia of Wit and Humor; one hundred of Lyell's Geology; ten of Thiers' French Revolution; ten of the Stratford Gallery, or the Shakespeare Sisterhood; ten of Shakespeare's Merchant of Venice (illustrated); six of Griswold's Saered Poets of England and America; twenty of Bishop Colenso's Pentateuch and Book of Joshua, critically examined; five of Bishop Doane's Life and Writings; together with a large number of juvenile-books, photographic albums, &c.

STOCK-RAISING IN THE SOUTH .- The New Orleans Picayune has the following:

Stock-Raising in the South.—The New Orleans Picagune has the following:

We see no other more practicable or remunerative employment of our corn surplus than in the raising and fattening of stock. The South is peculiarly favored for this business, in the great abundance of fine grazing lands, and in the longer period when these lands afford green food of the most nutritions character. Cattle can be kept fat in our piney woods pastures from the middle of April until the first of November, with no other food but the rich grass of these lands, of which there are millions of aeres, stretching in a belt of from one to two hundred miles wide, from the Mississippi river to the Virginia line. These lands are generally unoccupied, unclaiped, constituting commons, where any and everybody can graze their cattle with safety.

In the summer and spring the cattle that graze in these woods are in tip-top condition, but in the winter they get very poor and die off in great numbers for the want of food. The land is too poor and the population too sparse to produce corn or other food enough to keep them alive through the winter. Hitherto the cattle owners in this region have relied chiefly upon the wild cane, which used to be very abundant, to feed their cattle and even keep them fat in the winter. But this resource is rapidly falling.

One of the calamities which fell upon the people of the piney woods during the late war, was the seeding of the cane, which marks its decay and entire disappearance. To keep alive their cattle for the future, during the winter, their owners must have corn. They cannot raise it on their lands, and must buy and transport it from the more northern sections of their States, where it abounds. But to do this two things are needed which do not now exist, to wit: money to buy with and roads to transport on. These obstacles can be casily surmounted by energy and enterprise. Let our corn producers sell their corn to cattle raisers on shares, or exchange the same for cattle. If cattle can be driven from Ark

THE PENNSYLVANIA STATE DEBT REDUCED.—While other States are beginning to reflect seriously on the large additions they have made to their debts during the war, Pennsylvania has the satisfaction of reducing hers \$745,811.26, as officially announced by Governor Curtin in a proclamation. This has been made in a period when almost every State was under unusual expenses consequent upon the war, and when Pennsylvania especially, from her peculiar position, seemed most exposed, and therefore most liable, to military outlay. Deducting from the \$39,379,603 which constitutes the State debt, the \$10,300,000 of bonds of the Pennsylvania and Erie Railroad Company, we find that the debt before the late reduction was \$29,079,603, and that by paying off \$745,811, Governor Curtin has brought it down to \$28,333,792. The amount thus paid is larger than any yet paid for the same purpose, and next year it is expected that a full million will be paid.—Phil. North American.
