The Provost Marshal at New Orleans is rather exceeding his duties in ordering the striking from the register roll the names of parties whom he deems to have been disfoyal "antecedent to the amnesty proclamation of the President." This is a matter that does not concern him at all, and, further, it is an interference in the law of the State that will not be tolerated. I am not aware that the authorities have yet appealed to the President upon the subject. There is to be, in the future, no more military interference in the organization of State Government, and the "provo's" and all others may as well understand this at once.

Of the ratification of the slavery amendment there is no doubt, and this done, it will require the votes of but two more States to make the great work complete and binding for all time.

"Deeper, far deeper," says this letter, "is the secession foeling in the Church than ever it was in the State; nor is there the remotest probability that this feeling can ever be cradicated.

mistakably for a moment's doubt that the desire for a re-united Church comes all from one side.
