

GADDY, CHARLES TART, and DAVID BEASLEY, a free person of color, stand charged with said murder, and that said persons have fled from justice:

Now, know ye, that to the end justice may be done, and that said GADDY, TART and BEASLEY may be brought to legal trial for their offence, as aforesaid, I do hereby offer a reward of Two Thousand Dollars for the apprehension and delivery of the three offending parties in any jail in this State, or One Thousand Dol-

parties in any jail in this State, or One Thousand Dol-lars for NICHOLAS W. GADDY, the principal offend-er, and Five Hundred Dollars each for the others. When last heard from they wore in Horry District, near (fallivant's Forry.

Gaddy was born in Marion District, is about 35 years of age, 5, feet 10 or 11 inches high, grey eyes, auburn hair, rather sallow comploxion, stoops a little in the shoulders, usually wears his hair long-by oc-cupation a farmer and millwright.

Tart, born in same District, is a youth of about 16 years of age, well grown, rather fair complexion, dark huir, eyes believed to be blue.

Beasley, born in Richmond county, N. C., bright mulatto, thick set, weight from 160 to 180 pounds, from 45 to 50 years of age, 5 feet 11 or 12 inches high, kinky hair, and of reddish, sun-burnt appearance—by occupation a carpenter—has lived about Fayettville and Lumberton, N. C.
