# Slave Labor for the Coast,

COMMISSIONERS OF BOADS AND "HE town authorities within the Judicial Districts of Lancaster, Kershaw, Chesterfield, Darlington, Marl-boro, Marion, Sumter, Clarendon, Williamsburg, and Horry, will to:tlewith snummin all slaveholders within their respective limits to deliver ONE-HALF of their slaves, liable to road duty, at the Railroad depots nearest their residence, on TUESDAY THE 27TH DAY OF SEPTEMBER NEXT, at 8 o'clock, a. m., there to await transportation to Charleston, for thirty days labor on the fortifications.

11. The Confederate authorities have made a requisi-

tion upon the State for Two Thousand laborers monthly. The preportion of one-fourth heretofore called for, had failed to supply half of this number. In view of this fact and the great urgency of the domaind for labor at this time, it is deemed expedient to shorten the inter-val between the calls, and increase the quota.
