GENERAL ORDERS NO. 19.

PARAGRAPH I OF GENERAL ORDERS NO o 18, current series, from this office, requiring the companies organized for service beyond their Districts, and persons liable to said service out hot enrolled in companies; to proceed to Charleston, is hereby countermanded, and they will proceed to Hamburg, S. C., and report to Lieut. Col. W. G. DeSaussure, A. D. C., as heretefore directed.

II. Paragraph I of General Orders No. 16, current exemption from this office, requiring all persons claiming exemption from militia service on the ground of physical disability, to appear before the Examining Board at Columbia or the Surgeon-General at Hamburg, S. C, is so far modified that persons who have been re-cently examined by the Boards of Confederate Surgeons and exempted from Confederate service on the ground of permanent disability, will not be required to appear pelore the Board at Columbia or the Surgeon-General, but will transmit cubies of their certificates, through the commanding officers of companies formed in their regiments, to the Surgeon-General of the State—and in regiments where no companies have been organized, directly to the Surgeon-General-the copies of said certificate to be certified by a magistrate or a magistrate ex offici).

THE LAWS OF NEWSPAPARS. 1. SUBSCRIBERS WHO DO NOT CHE EX. PRESS notice to the contrary, are considered as wish-

ing to continue their subscription.

2. If subscribers order the discontinuance of their newspapers, the publisher may continue to send them

until all arrearages are paid! 3. If subscribers neglect or refuse to take their news-papers from the offices to which they are directed, they are hold responsible until they have settled the bills

and ordered them discontinued. 4. If subscribers remove to other places without informing the publishers, and the newspapers are sent to the former direction they are held responsible, for

5. The Courts have decided that refusing to take newspapers from the office or moving and leaving them uncalled for is "prima facis" evidence of intentional

-6. The Courts have also repeatedly decided that a postmaster who neglects to perform his duty of giving reasonable notice, as required by the Post Office Department, of the neglect of a person to take from the office newspapers addressed to him, renders the Postmasters liable to the publishers for the subscription.
