

Coutmeta, S. C, December 7, 1864. THE ACCOMPANYING ACT, RATIFIED BY the General Assembly, on the 6th instant, is published for the information of the militia of the State. By order of the Governor,

AN ACT TO ALTER AND AMEND THE MILITIA LAWS OF THE STATE.

SEC. 1. Be it cuacted by the Senate and House of SEC. 1. Be it enacted by the Senate and House of Representatives, now met and sitting in General Assembly, and by the authority of the some, That from and after the passage of this Aci, all free male white persons within this State, between the ages of sixteen and fifty not exempt from active service without the limits of the District in which they reside, by the militial laws of this State, shall be hable to active military duty without the limits of the State at the call of his Excellency the Governor.

SEC. That the Governor shall have authority, whenever in his judgment it is necessary for the defence of this State or of the adjacent States, to order but of the limits of the State, such portion of those liable to active military duty, and for such a length of time as in his judgment the extency may require.

And that in addition to the other penalties prescribed by law for defaulters.

Seo. 3. That all free male white persons within the

1880 4. That the Governor shall have power to allow an exemption or detail in such special cases, either of accessity or of public interest, as in his judgment should be made in either or both of the said classes of mile.
