The following is the exemption Act:

An Act to authorize the Governor to require the Exemption of certain State Officers and other persons from Confederate Service.

SECTION 1. Be it enacted by the Senate and

in General Assembly and by the authority of the same, That the Governor be and is hereby authorized and required to claim the exemption from Confederate military service of the officers and members of both branches of the General Assembly of this State, and the following State officers, to with Lieutenant-Governor, Judger of the Courts of Law and Eduity, At torney-General and Solicitors, Secretary of State, Comptroller General, State Auditor and two assistants, Treasurers of the Upper and Lower Division, Adjutant and Inspector General and one assistant, Quartemaster-General, Commissary-General, State Engineer and one assistant, Aides-de-Camp to the Governor (not to exceed one to each militia brigade,) Private Secretary of the Governor and his Clerk, Sheriffs, Clerks of the Court, Ordinaries, Masters, Registers, and Commissioners in Equity, Tax-Collectors, President, Cashier, Book-keeper, and one Teller of the Bank of the State and of each of its Branches, Officers and Cadets of the State Military Academies, Professors of the South Carolina College, Superintendent, Physician, and Keepers of the Lunatic Assylum, and Superintendent, Steward, and Teachers of the Asylum for the Deaf, Dumb and Blind.

Sec. 2. That the Governor be and he is hereby anthorized, if the same be in his judgment necessary, and under such regulations as he may prescribe, to require the exemption of the following State officers and other persons to wit : Members of the Board for the Relief of Soldiers' Families, (who are over forty-five years of age,) President, Cashier, Book keeper, and one Teller now in the employment of each of the several Banks in the State, the Presidents and Treasurers now in the employment of the two Savings Institutions in the States such Deputy-Sheriffs as may be indispensable to the execution of the laws of the State, (not to exceed one in each Judicial District,) State Agent for the supply of slave labor, one editor for each newspaper being published at the time of the passage of this Act, and such printers and pressmen as said editor may certify upon oath to be indispensable to the publication of said newspaper; the Public Printer of the State Government, and such journeymen printers as said Public Printer shall certify upon oath to be indispensable to the public printing; the Chief of the South Carolina Hospital Bureau at Richmond and his assistant; the officers and members of the Police and Fire Departments of Charleston and Columbia, and such artizans, mechanics and persons of scientific skill, and other employees as may be indispensable to the carrying on of the manufactories and public work belonging to the State; the professors and teachers of all incorporated colleges in the State; every minister of religion anthorized to preach according to the rules of his church, and who was, on the first day of May, 1861, andat the passage of this Act shall be regulary employed in the discharge of his ministerial duties, and is not engaged in any traffic.

SEC. 3. That for the proper police of the country, the Governor is hereby authorized, finder such regulations as he may prescribe. to require the exemption from Confederate military service of such persons as he may adjudge indispensable for the government of the slaves, and the protection of the citizens and property of the State : Provided, That such exemptions shall not exceed, in any District, one for every two hundred slaves in said District : And provided, further, That the rights of overseers now having both Confederate and State exemptions shall not be changed nor altered by the provisions of this Act, nor shall such persons be

included in the estimate of the above proviso. SEC. 4. That all officers and persons who shall be so required by the Governor, pursuant to the provisions of this Act, be and they are hereby declared to be exempt from Confederate military service during the period for which heir exemption shall be so claimed.

## LATEST BY

REPORTS OF THE PRANCE ACCOUNTION.

#### FROM VIRGINIA.

FREDERICKSBURG, Dec 25 .- The gallant Mosby received a dangerous, but not fatal wound last Wednesda -. He is in our hands, and well cared for. A raiding party entered West Moreland, and committed many depredations.

#### FROM WILMINGTON.

WILMINGTON, Dec. 24.—Seventy vessels of the enemy's fleet are reported off Fort Fisher this morning. No demonstration of landing yet. Weather mild. Wind west by north west. A Yankee gunboat ran aground last night near Fort Fisher and was blown up by the enemy.

WILMINGTON, Dec. 24. The Yankee gun-

boats were repulsed six miles below Fort Branch on Roanoke River, on Friday. Col Whitford was seriously wounded. The fight is expected to be renewed in the morning.

WILMINGTON, Dec. 24 .- The enemy's fleet drew up in line of battle off Fort Fisher, and opened on the fort at half past one o'clock, p. m., with the Iron-sides and fifty one other vessels. It is reported, but not officially, that several monitors and iron-clads are among them. The fight is still progressing at three o'clock p. m. Our people are quiet;

WITMINGTON, Dec. 24, 7 p. m .- The following official dispatch has been received, dated Fort Fisher 6 p. m: The bombardment conues. Weather rough. No attempt to pass the bar. No death casualties. Firing from the Fort slow and deliberate. Men in good spirits. Fleet drew off. Could not see that they went west.

WILMINGTON, Dec. 24.—The bombardment of Fort Fisher re opened this morning and continued furiously nearly all day. About three b'clock the enemy landed about two and a half iniles from Fisher, and continued to send troops to land under a heavy fire, opposed by our forces. Two brigades so far are on

Wilmington, Dec. 27 .- An official dispatch; dated 6 o'clock p. m., to-day, says : The enemy have evacuated Fort Anderson, and re-embarked. Fort Fisher is uninjured. The immediate danger has passed.


