 THE FOLLOWING REGULATIONS HAVE been adopted for the presentation and payment through this office, of requisitions and claims upon the Executive Department of this State:
 1. Whenever practicable, all requisitions for funds by the heads of military bureaux and works of the State, and all claims against the Executive Department of the State, shall be transmitted to this office for examination and audit at least one week before the first day of each month. Requisitions and claims approved by the Governor will be paid between the 5th and 10th days of the month next succeeding the one in which they were submitted for audit.
 2. Except under special circumstances, funds will not be remitted by mail. Parties who desire to receive amounts through agents will please observe the following form of power of attorney:
 I, _____, do hereby appoint _____ my true and lawful attorney to sign receipts for and receive payment of all money which may be now due or coming to me from the Executive Department of the State of South Carolina.
 Witness my hand and seal _____, this _____ day, _____ (L. S.)
 3. No bill will be paid unless sworn to by the claimant, and no requisition will be allowed unless prepared as near as may be, according to the forms prescribed by the army regulations of the Confederate States, and certified in duplicate by the proper officer of the department or service for which the requisition is made.
 4. All requisitions and claims of the character here-in referred to, that were rendered previous to the date of this notice, and which have been audited and approved, will be paid as heretofore, upon application to this office.

PERSONS desiring to have their bills printed for the Legislature will submit their bills to the printer of the House of Representatives, in Columbia, S. C., on or before the 1st day of December, 1864.
 The following bills will be printed:
 Bills, in Pica, 62 lines, of 35 ems—2,170 ems per page.
 Reports and Documents, Long Primer, 55 lines, of 31 ems each—1,705 ems per page.
 Permanent Journal, Long Primer, 55 lines, of 31 ems each—1,705 ems per page.
 Calendars of the two Houses, Long Primer, 55 lines, of 31 ems each—1,705 ems per page.
 The Bills to be printed on good writing paper, and all other printing to be done on printing paper, of as fine quality as can be procured.
 Extra copies of every paper ordered to be printed by either House, must be furnished to each member of the other branch of the Legislature.
 Of the Bills, Reports, Documents, Journal and Calendar, two hundred copies are required daily, one hundred and fifty for the members of the House of Representatives, and fifty for the members of the Senate.
 The Journal and Calendar must be delivered punctually at or before the hour of meeting of the Houses of each day, and one copy by the same hour, to be delivered at the Executive Department, and one copy to the State Auditor.
 The Acts and Permanent Forms of the Houses must be printed, stitched and ready for delivery by the 20th of February, after the regular session. Rule and figure work to count double, and pages and side notes to be estimated at the rate of 1,705 ems per page.
 The two Houses will separately choose the Printer of their daily work, and will unite in the selection of the Printer of their permanent work, viz: Acts, Reports, Resolutions, &c.
 Proposals for the Printing of the two Houses, or of either House, must conform to the foregoing specifications.

THE LAWS OF NEWSPAPERS.

1. SUBSCRIBERS WHO DO NOT GIVE EXPRESS notice to the contrary, are considered as wishing to continue their subscription.
 2. If subscribers order the discontinuance of their newspapers, the publisher may continue to send them until all arrearages are paid.
 3. If subscribers neglect or refuse to take their newspapers from the offices to which they are directed, they are held responsible until they have settled the bills and ordered them discontinued.
 4. If subscribers remove to other places without informing the publishers, and the newspapers are sent to the former direction they are held responsible, for the same.
 5. The Courts have decided that refusing to take newspapers from the office or moving and leaving them uncalled for is "prima facis" evidence of intentional fraud.
 6. The Courts have also repeatedly decided that a postmaster who neglects to perform his duty of giving reasonable notice, as required by the Post Office Department, of the neglect of a person to take from the office newspapers addressed to him, renders the Postmaster liable to the publishers for the subscription price.
