and river. Two companies were sent out in pursuit of the Mexicans, and after following them fifty miles, returned stating that they had not approached nearer to them than six hours travel.

The blockade of Vera Cruz commenced on the 20th ultimo, and fifteen days were allowed neutral vessels in port to load and depart. News had reached Vera Cruz that Mazatlan and Tepic had pronounced in favor of SANTA ANA; that PAREDEES intended to leave the city of Mexico at the head of more troops to reinforce the army of the north.

From the enormous forced loans which the Government has imposed upon the clergy, it would appear that the war is to be prosecuted with vigor. The Metropolitan Church was ordered to furnish a subsidy of \$98,000 per month; the church of Michoacan \$35,-000; of Puebla \$40,000; of Guadalajara \$20,000; of Durango \$15,000; and of Oajaca \$8,000.

Foreign News .- Upon the first page of this week's paper will be found extracts of foreign news brought out by the steamer Great Britain. The news is not of much importance, with the exception of the English presses upon the Oregon question, and the advance of an 1-8d in the price of cotton.

Since the arrival of the Great Britain, the Cambria has arrived, bringing advices up to the 19th ultimo, which are also of little importance, but giving an advance still in the cotton market. The Corn Law has passed the House of Commons by a large majority, and is thought will pass the House of Lords also. Upon the Oregon question, the London Times says :-

"The packet which will sail from Liverpool in a few days will convey to the United States the real impression produced here by the late intelligence. If the resolution was intended as a threat or a hostile measure, it has totally failed to have any effect whatever, except that it is probable Mr. Pakenham will be at once empowered to bring the controversy to a prompt and final issue. The London Economist states, on what it considers high and unquestionable authority, that the Oregon question is on the point of a satisfactory settlement."

For the information of persons throughout the State desirous of volunteering under the recent requisition, it is ordered for publication.

That after the organization of the Regiment, a system of Company drill will be commenced, to be conducted under the general direction and superintendence of the Adjutant and Inspector General, but not to exceed one drill per week for each

The Companies to compose the Regi ment must be of Infantry, therefore Riflemen volunteering must signify their willingness to enter that arm of the service; and no company will be withdrawn from its District until the Regiment is ordered out and concentrated for the purpose of being mustered into service.

The 3d and 4th sections of the Act of Congress, providing for the prosecution of the war between the United States and Mexico, contain important information, and are therefore annexed

By order of the Commander-in-Chief. J. W. CANTEY, Adj. and Insp. Gen. "Sec. 3 And be it further enacted, That the said volunteers shall furnish their own clothes, and when mustered into service shall be armed at the expense of the United States.

"Sec. 4. And be it further enacted, That said volunteers shall, when called into active service, and while remaining therein, be subject to the rules and articles of war, and shall be in all respects, except as to cloththing and pay, placed on the same footing with similar corps of the U. S. army, and in lieu of clothing, every non-commissioned officer and private in any company who may thus offer himself, shall be entitled when called into actual service, to receive in money a sum, equal to the cost of clothing of a non commissioned officer or private (as the case may be) in the regular troops of the the U. States."
