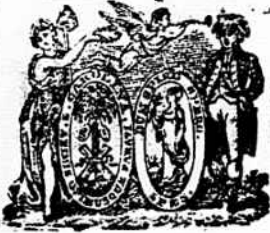

**To Manufacturers.**

BY AUTHORITY OF THE ACT OF THE GENERAL Assembly December, 1864, "The Soldier's Board of Relief" of Kershaw District, require all Manufacturers of Cotton and Woollen Goods, including Yarns, Iron, Nails and other iron ware; Cotton and Wool Cards, Hats, Caps, Paper, Stoneware and Pottery; Leather, Shoes, Boots, Salt, Copperas, Spirituous Liquors, Terebene Oil, and Turpentine, to deliver, to the Board, or any member thereof, or to the Treasurer, on or before the 1st of February next, a statement in writing, under oath, setting forth such and so many of the above articles as were manufactured by them in the year eight hundred and sixty-four; and to deliver to the said Board or their officer in Camden, on or before the said first day of February next, a Tax-in-Kind of three per cent. of all manufactures embraced in their said returns.

In default of such return or payment, the Board will proceed to estimate the amount of such manufactured products, and assess a Tax-in-Kind thereon of six per cent., and issue execution for three times market value thereof.

**GENERAL ORDER NO. 5.**

IN PURSUANCE OF ORDER FROM A. C. GARLINGTON Adjutant and Inspector General of S. C., Captains or officers commanding beat companies are hereby ordered to have enrolled all white male persons between the ages of sixteen and sixty years, in their respective Beats—except only persons who have been exempted by the Surgeon General of the State, or the State Board of Surgeons at Columbia, S. C., on the ground of permanent physical disability, and persons detained by Confederate authority, and make their returns to these headquarters on or before the 14th instant.

2. Those who claim exemption on the ground of physical disability, but who have not certificates from the Surgeon General or the State Board of Surgeons of recent date, will nevertheless be enrolled and be examined by the District Surgeon to be hereafter appointed.

3. Officers commanding Beat Companies will have all vacancies of officers in their respective commands filled by election or by appointment, according to law, and make their returns to these headquarters as above.

4. All officers failing to obey these orders will be dealt with as the law directs. (See General Order No. 22, paragraph 6, Adjutant and Inspector General.)

**THE LAWS OF NEWSPAPERS.**

1. SUBSCRIBERS WHO DO NOT GIVE EXPRESS notice to the contrary, are considered as wishing to continue their subscription.
2. If subscribers order the discontinuance of their newspapers, the publisher may continue to send them until all arrearages are paid.
3. If subscribers neglect or refuse to take their newspapers from the offices to which they are directed, they are held responsible until they have settled the bills and ordered them discontinued.
4. If subscribers remove to other places without informing the publishers, and the newspapers are sent to the former direction they are held responsible for the same.
5. The Courts have decided that refusing to take newspapers from the office or moving and leaving them unclaimed for is "prima facie" evidence of intentional fraud.
