### SHORTAGES IN SALUDA COUNTY

REPORT OF THE EXPERT AC-

COUNTANTS.

The Shortages Not Large and Probably Due To Bad Bookkeeping Rather Than Intentional Wrong.

The grand jury of Saluda county has had a special committee at work on the financial condition of the county for the past several months and they had a special expert to examine the books of the officers. The report was made last Monday. We give below the report of the expert, Mr. A. J. Haltiwanger, as printed in the Saluda Standard of last week.

Our special committee appointed to examine the books of county officials have submitted the following report: Expert Accountant's Report.

Saluda, S. C., November 18, 1905. Messrs. Jas. D. Watson, R. M. Blease and L. M. Werts, Committee. Dear Sirs:

I beg to hand you herewith a report of the books of the officials of Saluda county:

Exhibit B is a list of claims paid on by the treasurer which were not in accordance with law, as they were defective in not having the signature of either the Supervisor or the Secretary or the county seal.

\$3,111.25 These aggregate Ehibit B is a list of claims paid on warrants issued by county supervisor without approval of county commissioners.

\$47,019.69 These aggregate Exhibit C is a list of claims which were raised in the amounts stated.

This aggregates Exhibit D is a list of warrants varying from amount of claims.

The cash books of the treasurer, Mr. H. B. White, were examined and balanced to date and found to be cor-

I find a number of warrants not endorsed.

Auditor fails in numerous cases to into his office, thus leaving them in condition to be used a second time. His records are not complete, as one year's settlement sheets could not be

Many of the claims that have discount added were changed after being proven, and many of them changed in the affidavits. I find a number of claims in names of other parties paid to officers of county, namely: B. W. Crouch, County Attorney, and B. R. the wife of the county treasurer, Mrs. B. R. Smith.

On claim record of supervisor the work has not been classified, and numbers of warrant issued not made a matter of record.

On books of the county dispenser I find no itemized account after May 5, 1904, and even before that time the last day or two of the month was not itemized, so as to even up matters, I presume.

Upon application to Mr. J. P. Lindler, the former dispenser, for the books during his incumbency, and also those of his predecessors, he stated that he had carried them home and the rats ate them up and he burned the pieces that were left. For this cause we could only get a record covering the period named in Exhibit M, which in itself is very unsatisfactory.

April 5,1904, claim No. 150, Warrant Exhibit E is a list of claims which No. 356 payable to P. J. Coleman, includes \$5.00 for work on committee

> visor's office it appears P. J. Coleman, clerk of the board, received 5 per cent commission from E. T. Barnum Iron Works on purchase of steel cages for jail.

All notes which I found for borrowed money except those to Sinking Fund bore 8 per cent interest. It is questionable in my mind if they could legally pay that rate. Very few of the notes were legally signed.

On the clerk's books no fines and forfeitures appear of record from June 15, 1904 to June 15, 1905.

I am informed that Mr. B. R. Smith loaned sums of money, presumably nomination. county funds, to the Bank of Johnston haps others. Nowhere on the treasurer's books do I find that the interest on these loans found its way into the county treasury.

Exhibit Q is a report of delinquent taxes 'turned over to Sheriff's office for collection. This shows amounts and percentage collected on same.

The books in this office as also the Democratic primary. those in the offices of the Clerk of Court, Superintendent of Education and those of the present county treasurer are well kept and in good condition. During the incumbency of the former treasurer, B. R. Smith, covering a period of four years, the cash book for county funds was not written up at all, and this I had to write up myself.
