The bill authorizing and directing the Pee Dee Bridge Commission to a bridge across the Pee Dee build river at Mars Bluff Ferry was agreed upon and passed Thursday. The following is the text of the

bill as adopted: Mr. Hughes asked and obtained

unanimous consent to offer the following amendment, which amendment was unanimously agreed to: Amend said Joint Resolution by striking out all after the resolving words and insert in lieu thereof the following:

"Whereas, it will be of great advantage to the eastern, and southern parts of the State that a bridge be built across Great Pee Dee river, at Mars Bluff Ferry; and

Whereas, the erection of a sub-stantial and suitable bridge, as aforesaid, would cost the sum of four hundred thousand (\$4,00000.00) dollars; and,

Whereas, of the amount of four hundred thousand (\$400,000 dollars the State Highway Commission, through federal aid, has agreed and will pay one-half the cost, to wit, the sum of two hundred thousand (\$200,-000) dollars; therefore,




