REVISED COVENANT OF LEAGUE OF NATIONS NOW BEFORE CONFERENCE

Document Designed to Promote International Co-Operation and to Achieve International Peace and Security With-

out Resort to War.

FOR CLEARER UNDERSTANDINGS OF INTERNATIONAL LAW

The High Contracting Parties Agree in This Covenant to Main tain a Scrupulous Respect for All Treaty Obligations in All Their Dealings With One Another.

Covenant of the League of Nations. In order to promote international co-operation and to achieve international peace and security, by the acceptance of obligations not to resort to war, by the prescription of open, just and honorable relations between nations, by the firm establishment of the understandings of international law as to actual rule of conduct among governments, and by the maintenance of justice and a scrupulous respect for all treaty obligations in the dealings of organized peoples with one another, the high contracting parties agree to entative. this covenant of the league of nations.

(In the original preamble the last sentence reads; "adopt this constitution," instead of "agree to this cove-

Article One.

The original members of the league of nations shall be those of the signatories which are named in the annex to this covenant and also such of those other states named in the annex as shall accede without reservation to this covenant. Such accession shall be effected by a declaration d posited with the secretariat within two months of the coming into force of the covenant. Notice thereof shall be sent to all other members of the

Any fully self-governing state, dominion or colony not named in the annex may become a member of the league of nations if its admission is agreed to by two-thirds of the assembly, provided that it shall give effective guarantees of its sincere intention to observe its international obligations, and shall accept such regulations as may be prescribed by the league in regard to its military and naval forces and armaments.

Any member of the league, may, after two years' notice of its intention so to do, withdraw from the league, provided that all its international obligations and all its obligations under this covenant shall have been fulfilled at the time of its withdrawal.

Article Two.

The action of the league under this covenant shall be effected through the instrumentality of an assembly and of a council, with a permanent secretariat.

(Originally this was a part of article one. It gives the name assembly to the gathering of representatives of the members of the league, formerly referred to merely as "the body of delegates.")

Article Three. The assembly shall consist of representatives of the members of the

The assembly shall meet at stated intervals and from time to time as occasion may require, at the seat of the league, or at such other place as may be decided upon.

The assembly may deal at its meet ings with any matter within the sphere of action of the league or af fecting the peace of the world.

At meetings of the assembly, each member of the league shall have one vote, and may have not more than three representatives.

(This embodies parts of the original inal article one, two and three with only minor changes. It refers to "members of the league" where the term "high contracting parties" originally was used, and this change is followed throughout the revised draft.) Article Four.

The council may deal at its meet ings with any matter within the sphere of action of the league or affecting the peace of the world.

Any member of the league not represented on the council shall be invited to send a representative to sit as a member at any meeting of the council during the consideration of matters specifically affecting the interests of that member of the league. At meetings of the council, each member of the league represented on the council shall have one vote, and may have not more than one repres-

(This embodies that part of the original article three designating the original members of the council. The paragraph providing for increase in the membership of the council is new.)

Article Five. Except where otherwise expressly provided in this covenant, decisions at any meeting of the assembly or of the council shall require the agreement of all the members of the league represented at the meeting.

All matters of procedure at meetings of the assembly or of the council, the appointment of committees to investigate particular matters shall be regulated by the assembly or by the council and may be decided by a majority of the members of the league represented at the meeting.

The first meeting of the assembly and the first meeting at the council shall be summoned by the President of the United States of America.

(The first paragraph requiring unanimous agreement in both assembly and council except where otherwise provided is new. The other two paragraphs originally were included in article four.)

Article Six.

The permanent secretariat shall be established at the seat of the league. The secretariat shall comprise a secretariat general and such secretaries and staff as may be required.

The first secretary general shall be the person named in the annex; there-(This article is new, embodying after the secretary general shall be appointed by the council with the ap-

proval of the majority of the assembly. The secretaries and the staff of the secretariat shall be appointed by the secretary general with the approval of the council.

The secretary general shall act in that capacity at all meetings of the assembly and of the council. .

The expenses of the secretariat shall be borne by the members of the league in accordance with the apportion ment of the expenses of the international bureau of universal postal

(This replaces the original article five. In the original the appointment of the first secretary general was left to the council, and approval of the majority of the assembly was not required for subsequent appointments.)

. Article Seven.

The seat of the league is established at Geneva

The council may at any time decide that the seat of the league shall be established elsewhere.

All positions under or in connection with the league, including the secre tariat, shall be open equally to men and women.

Representatives of the members of the league and officials of the league when engaged on the business of the league shall enjoy diplomatic privi

leges and immunities. The building and other property of cupied by the league or its officials or by representatives attending its meet

Article Eight

The members of the league recogmize that the maintenance of a peace requires the reduction of national armament to the lowest point consistin its discretion. Article Nine.

A permanent commission shall be the expectation of the provisions of articles one and eight and on military and naval questions generally.

(Unchanged except for the insertion of the words "article one").

Article Ten. The members of the league undertake to respect and preserve as against external aggression the territorial integrity and existing political independence of all members of the league. In case of any such aggression, or in case of any threat or danver of such aggression, the council shall advise upon the means by which his obligation shall be fulfilled.

(Virtually unchanged). Article Eleven.

Any war or threat of war, whether mmediately affecting any of the members of the league or not, is nereby declared a matter of concern to the whole league, and the league shall take any action that may be deemed wise and effectual to saferuard the peace of nations. In case any such emergencies should arise, the secretary general shall on the reequest of any member of the league, 'orthwith summon a meeting of the

It is also declared to be the fundanental right of each member of the league to bring to the attention of the assembly or of the council any circumstances whatever affecting international relations which threatens to disturb either the peace or the good understanding between nations upon which peace depends.

Article Twelve.

The members of the league agree that, if there should arise between them any dispute likely to lead to a rupture, they will submit the matter either to arbitration or to inquiry by the council, and they agree in no case to resort to war until three months after the award by the arbitrators or the report of the council.

In any case under this article the award of the arbitrators shall be made with in a reasonable time, and the report of the council shall be made within a reasonable time, and submission of the dispute.

Article Thirteen.

The members of the league agree that whnever any dispute shall arise between them which they recognize to be suitable for submission to arbitration and which cannot be satisfactorily settled by diplomacy, they will or financial relations, the prohibition submit the whole subject matter to arbitration. If the council fails to reach a report which is unanimously agreed to by the members thereof, other than the representatives of one or more of the parties to the dispute, the members of the league reserve to themselves the right to take such action as they shall consider necessary for the maintenace of right and jus-

If the dispute between the parties is claimed by one of them, and is cound by the council, to arise out of a matter which by international law is solely within the domestic jurisdiction of the party, the council shall so report, and shall make no recommenlations as to its settlement.

The council may in any case under this article refer the dispute to the assembly. The dispute shall be so reterred at the request of either party to the dispute, provided that such request be made within 14 days after the submission of the dispute to the

In any case referred to the assembly all the provisions of this article and of article 12 relating to the action and powers of the council shall apply to the action and powers of the as sembly, provided that a report made by the assembly, if concurred in by the representatives of those members of the league represented on the council and of a majority of the other members of the league, exclusive in each case of the representatives of the parties to the dispute, shall have the same force as a report by the council concurred in by all the members thereof other than the representatives of one or more of the parties

to the dispute. (The paragraph specifically excluding matters of "domestic jurisdiction" from action by the council is new. In the last sentence, the words "if concurred in by the representatives of those members of the league represented on the council," etc., have been added).

Article Sixteen. Should any member of the league esort to war in disregard of its covenants under articles 12, 13 or 15, it shall ipso facto be deeemd to have committed an act of war against all other members of the league, which thereby undertake immediately to subject it to the severance of all trade of all intercourse between their nations and the nationals of the covenant-breaking state and the prevention of all financial, commercial or personal intercourse between the nations of the covenant breaking state and the nations of any other state. whether a member of the league or

It shall be the duty of the council in such cases to recommend to the several governments concerned what effective military or naval forces the members of the league shall severally contribute to the armaments of forces to be used to protect the covenants of

the league. The members of the league agree, further, that they will mutually support one another in the financial and economic measures which are taken under this article, in order to minimize the loss and inconvenience resulting from the above measures, and that they will mutually support one another in resisting any special measures aimed at one of their number by the covenant breaking state and that they will take the necessary steps to afford passage through their territory to the forces of any of the members of the league which are co-operating to protect the covenants of the

Any member of the league which violated any covenant of the league may be decided to be no longer a member of the league by a vote fo the council concurred in by the representatives of all the other members of the league represented thereon.

Article Seventeen.

Article Twenty-two.

Te those colonies and territories which as a consequence of the late war have ceased to be under the sovereignty of the states which formerly governed them and which are inhabited by peoples not yet able to stand by themselves under the strenuous conditions of the modern world, there should be applied the principle that the wellbeing and well development of such peoples formed a sacred trust of civilization and that securities for the performance of this trust should be embodied in this covenant.

The best method of giving practicable effect to this principle is that the tutelage of such peoples be entrusted to advanced nations who, by reasons of their resources, their experience or their geographical position, can best undertake responsibility, and which are willing to accept it, and that this tutelage should be exercised by them as mandatories on behalf of the league.

The character of the mandate must differ according to the stage of the development of the people, the geographical situation of the territory, its economic condition and any other similar circumstances.

Certain communities formerly belonging to the Turkish empire have reached a stage of development where their existence as independent nations can be provisionally recognized subject to the rendering of administrative advice and assistance by a mandatory until such time as they are able to stand alone. The wishes of these communities must be a principal consideration in the selection of the mandatory.

Other peoples, especially those of Central Africa, are at such a stage that the mandatory must be responsible for the administration of the territory under conditions which will guarantee freedom and conscience or religion subject only to the maintenance of public order and morals, the prohibition of abuses, such as the slave trade, the arms traffic and the liquor traffic and the prevention of the establishment of fortifications or ada, Australia, South Africa, New training of the nations for other than policy purposes and the defense of territory and will also secure equal opportunities for the trade and commerce of other, members of the league.

There are territories, such as Southwest Africa, and certain of the South Pacific islands, which, owing to the sparseness of their population or their small size or their remoteness from the centers of civilization or their geographical contiguity to the terri-tory of the mandatory and other circumstances, can be best administered under the laws of the mandatory as

integral portions of its territory subject to the safeguards above mentioned in the interests of the indigenous population. In every case of mandate the mandatory shall render to the council an annual report in reference to the territory committed to its

The degree of authority, control or administration to be exercised by the mandatory shall, if not previously agreed upon by the members of the league, be explicitly defined in each case by the council.

A permanent commission shall be constituted to receive and examine the annual reports of the mandatories and to advise the council on all matters relating to the observance of the

There shall be placed under the direction of the league all international bureaus already established by general treaties if the parties to such treaties consent. All such international bureaus and all commissions for the regulation of matters of international interest hereafter constituted shall be placed under the direction

of the league. In all matters of international interest which are regulated by general conventions, but which are not placed under the control of international bureaus or commissions, the secretariat of the league shall, subject to the consent of the council, and if desired by the parties, collect and distribute all relevant information and shall render any other assistance which may be necessary or desirable.

The council may include as part of the expenses of the secretariat the expenses of any bureau or commission which is placed under the direc-

tion of the league. (Same as article 22 in the original, with the matter after the first two sentences added).

Article Twenty-five.

The members of the league agree to encourage and promote the establishment and co-operation of duly authorized national Red Cross societies having as purposes improvement of health, the prevention of diseases and the mitigation of suffering through-

out the world. (Entirely new.)

Article Twenty-six. Amendments to this covenant will take effect when ratified by members of the league, whose representatives compose the council and by a majority of the members of the league whose representatives compose the

Such amendment shall (the word not apparently omitted in cable transmission) bind any member of the league which signifies its dissent therefrom, but in that case it shall cease to be a member of the league.
