STATE OFFICIALS  
HAVE EASY TIME  
PRACTICALLY NO OPPOSITION FOR REELECTION.  
EXCEPT IN PERHAPS TWO CASES.  
THE SURPRISE OF THE DAY WAS ANNOUNCEMENT OF COL. HENRY T. THOMPSON

When the time for filing pledges for State officers closed Tuesday at noon at the office of State Chairman Willie Jones there was but one additional entry of State-wide importance—that of Col. Henry T. Thompson of Columbia for adjutant general.  
The announcement of Col. Thompson came somewhat as a surprise to many who thought that the incumbent, Gen. J. C. Boyd, would have no opposition. Gen. Boyd has served two years and was formerly colonel of the First regiment, with headquarters in Greenville. He is a Confederate veteran and since his election has lived in Columbia.  
Col. Thompson has been a lifelong member of the militia and now commands the Second regiment. It is probable that neither of the candidates will be able to attend the first few meetings on account of the encampment, which commences today on Sullivan's Island, but letters will be sent to each of the county chairmen, outlining the platform and reasons for election.  
The other State officers remain practically as mentioned several days ago in The State. Gov. Ansel will have some opposition from C. L. Blease of Newberry. His excellency will attend the first meetings of the campaign, as will nearly all of the State officers, even those who are unopposed, but it is hardly probable that this will be kept up for more than the first few meetings.  
For state superintendent of education Styles R. Melcham of Orangeburg, E. C. Elmore of Spartanburg and John E. Swearingen of Cedar Springs, formerly of Edgely, will make the race.  
For railroad commissioner Chairman B. L. Coughtain of this city will offer for reelection, being opposed by James Candler of Tazewell, F. C. Fishburne of Charleston, J. A. Sumner of Columbia and H. W. Richardson of Columbia.  
For comptroller general Mr. N. W. Brooker of this city will oppose the incumbent, Hon. A. W. Jones. The others are:

### MEMORIES OF MY FIRST SCHOOL.

[CONTINUED.]  
In my letter of last week I forgot to mention the fact that the scholastic year was eleven months, and that the school hours were from 8 o'clock a. m. to one hour before sunset in the afternoon, with no intermission except one hour at noon for dinner and "play time."  
My second year's experience at school was under a different teacher—one of more culture than the former but less discipline. In fact the scholars ruled the teacher instead of him governing them. The school was composed of some grown girls and young men who took such liberties as they chose. The result was but little progress was made in their studies. Two of those young men, years afterwards, volunteered in Capt. Preston S. Brooks' company, from Edgely, for service in the Mexican war and were killed in battle by the same cannon ball along with others who fell from the same missile of death.  
I never knew whence this teacher came nor whether he went. The building in which he taught was more commodious and better equipped. It is a sad reflection when I call to mind how few there are now living who shared with me the inconveniences and rudeness of our primary education.

### CANDIDATES FOR THE SENATE.

SIX IN THE RACE FOR THE LATE LATIMER'S SEAT.

LUMPKIN AND GRACE CAME IN

THE ENTRY OF MR. LUMPKIN CREATED QUITE A SURPRISE AMONG THOSE INTERESTED.

Things happened rapidly at the office of State Chairman Willie Jones Tuesday just before the time for filing pledges ended, and as a result there were several political surprises. There were two more entries in the race for the senatorial togo—John P. Grace of Charleston and Col. W. W. Lumpkin of this city. This makes seven candidates in all, and as a result all who take interest in such are speculating as to results. Those who have entered for the place in Washington are:  
John Gary Evans of Spartanburg, George Johnstone of Newberry, C. B. Martin of Columbia, R. G. Rhett of Charleston, E. D. Smith of Florence, John P. Grace of Charleston, W. W. Lumpkin of Columbia.  
The first three named have been announced candidates for some time. Mr. Rhett, the mayor of Charleston, announced his candidacy just after the withdrawal of former Gov. Heyward, who is now in Philadelphia for his health.  
Mr. E. D. Smith of Florence, who is prominently identified with the Cotton association of this State, announced himself just after the death of Senator Latimer. The entrance of Grace is therefore somewhat of a surprise. It is known that Mr. Grace is antagonistic to Mayor Rhett and, in fact, during the State convention attempted to split the Charleston delegation on the nomination of delegates to the national convention, being a candidate for delegate at large. His entrance, therefore, is construed to mean a movement against the Mayor of Charleston.  
The entrance of Col. Lumpkin was another one of the unexpected happenings. Col. Lumpkin two years ago entered the race against Senator Tillman, but later withdrew on account of the orders of his physicians and with the determination to run again. He has for years been a resident of Columbia, has taken a prominent part in the work of the Confederate veterans and is well known all over South Carolina.  
The other candidates are well known to the people of the state. Mr. Evans is a former governor and ran against the late Senator Latimer six years ago. Col. Johnstone was also a candidate at that time. Mr. Martin has been State superintendent of education for three terms. He announced some time ago in an interview that he would not run for reelection, but would be a candidate for the United States senate. This was before the death of Senator Latimer.

### HENDERSON OFF FOR EUROPE.

HENDERSON OFF FOR EUROPE.  
DECLINES TO ENTER RACE FOR THE SENATE A SECOND TIME.

Aiken, June 16.—It is now definitely settled that Hon. D. S. Henderson will not re-enter the race for the United States Senate, as he left on Sunday night for New York, thence to sail on Wednesday for London, and will spend the summer in Europe. It is understood that he has been strongly urged to re-enter the race since the withdrawal of Governor Heyward; and a great deal has been said by the papers of this section in regard to the matter. Col. Henderson, his, however, never consented to enter the race the second time, and his departure settles all conjecture as to any action in this direction, as he will not return to South Carolina before the first of September, or perhaps later.
