MONEY ORDER BUSINESS. - This business is considerable at this office, and should increase as the only secure way of transmitting through the mail. This is the dull season of the year, in that as well as every other kind of business. During the month of July \$1,581.00 were sent in money orders, from the Orangeburg office, which is much below the average monthly business.

The trial of John D. Lee the Mormon bishop, who was concerned in the massacre of the emigrant train from Arkansas, in September, 1857, at Mountain Meadow, is now in progress at Beaver, Utah. What will be the result is not very certain. So many years have elapsed that it will be difficult to bring forward such evidence as will warrant the infliction of adequate punishment upon those concerned in the crime. And besides there is the difficulty of securing a jury that will not endeavor to favor the Mormons.

The lower end of Russel street, where several new buildings are going up, is lumbered up with bricks, planks, deal-trees, and debris, which should receive the attention of our city fathers.

Some valuable property was sold last Monday. There seemed to be several bidders for the office opposite the court house square, belonging to the Oliver estate. It was finally knocked down to Maj. Whaley at \$1,300. We learn that J. D. Treville, Esq., will occupy one of the rooms as a law office, and Maj. Whaley the other.

CADIT SHIP. - Congressman Mackey of this district does not propose to prostrate the prerogatives of his office to bring money to his own pocket as is too often the case. He prefers to confer his favors upon those most worthy to receive them. He has just appointed Mr. N. J. Jenkins cadet at West Point, he having taken the highest rank at a competitive examination held at Charleston last Saturday.

We have received a copy of a pamphlet giving the programme of the third annual exhibition of the Orangeburg Agricultural and Mechanical Association to be held in the town of Orangeburg, S. C., commencing Tuesday, October 26, and closing Friday, October 29, 1875. The book is well gotten up, and printed by Walker, Evans & Coggeswell, Charleston, S. C. It contains a full list of premiums, and all necessary information in reference to the annual exhibition.

A few days since a daring outrage was committed at S. M. Fairry's place, about seven miles from this place, on the Charleston road. A colored man, who had been lurking about for several days, entered Mr. Fairry's house during the absence of the family, and finding a servant woman, named Bridget Baxter, beat her in the most inhuman manner to compel her to disclose where Mr. Fairry kept his money. The villain was unsuccessful in securing plunder, but the woman is in a dangerous condition. Great excitement prevails in the neighborhood.

From the account we conclude that the West have received in addition to its portion, by some freak of nature, the rains that should have made our fields high in an abundant harvest. Accidents from upper Mississippi, Missouri and Illinois suggest that all the rivers are rising rapidly, and all tributaries within 200 miles are all greatly swollen, many of them pouring out in floods. De-patches from various parts of the State say that immense damage has been done to crops and town property generally.

Last Monday a large number of people, estimated twenty five hundred, from various portions of the State, convened at this place to celebrate the anniversary of the emancipation of the British West India slaves. The meeting was organized by electing Hon. S. L. Duncan chairman, and T. K. Sasportas, Esq., secretary. Adjutant and Inspector General Purvis, Rev. T. H. Jackson, Gen. R. B. Elliott, W. J. Whipper, representative from Beaufort, and Ben. Byas, addressed the meeting. Good order prevailed and all seemed well pleased with the meeting.

D. Bowman in reference to the matter. The object is a good one, and we commend it to the public; but at the same time it is the duty of the school trustees to consult the convenience of the public and the healthfulness of the location, in selecting a site for a school house. A lot in a burying ground or a swamp, or one outside of the district would hardly be considered a desirable place.

The body of an unknown man apparently about twenty years of age, was discovered by the section hands Tuesday morning, about half a mile below this station on the S. C. R. R., fearfully mangled. The wheels had passed over both legs, the left being severed from the body. It is supposed that he was stealing a ride on the two o'clock train for Columbia, and by some mishap fell under the wheels. An inquest was held by Trial Justice Girardeau, and verdict given in accordance with the facts.

SOLD AGAIN. - The fine lot on Seate street, containing three-quarter of an acre, upon which the residence of Judge Andrews was burned last winter, and which was sold by the sheriff on Monday for \$650, was sold again yesterday for \$200, at the risk of the former purchaser, Mr. John Agnew being the purchaser. - Union Herald.

EX-PRESIDENT JOHNSON'S death will be regretted by none more deeply than by the insurance companies. He was a believer in life insurance, and illustrated his faith by his acts, to an extent that is rare indeed, even nowadays. The aggregate of the policies on his life is no less than Three Hundred and Fifty Thousand Dollars. His happy heirs can well afford to say no more about his little pile of seventy thousand dollars, which the ex-President lost by the bankruptcy of Jay Cooke's bank.

FALSE ALARM. - An alarm of fire was raised last Wednesday night about eleven o'clock, but the fire proved to have no existence save in the bosom of a wrathful benedict, who was giving his wife a substantial reminder of his right to command, and her duty to obey. The wife cried "murder," and some one mistaking it for "fire," took up the refrain, the bells pealed forth the dread alarm, firemen hurried to the scene of action, and, withal, the conjugal infelicity of this unhappy pair was the occasion of quite a public commotion.

The fall elections, this year, though of no great importance intrinsically, will be watched with interest on account of their bearing on the Presidential campaign of next year. The first comes off in California September 1, the Arkansas election comes one week later, and that of Maine follows, September 13, Iowa and Ohio vote October 12; New York, New Jersey, Pennsylvania, Massachusetts, Maryland, Mississippi, Minnesota, Kansas and Virginia hold their elections November 2, and Texas votes the following week. The chief interest, of course, centres in Ohio, where the battle will be fought, in part, upon the issue of Forceful Resumption.

NEW COURT HOUSE. - There are indications that the work will soon commence upon the new court house. A large pile of white sand, and a pile of material, of about the same stability, called brick, in the court house square make some showing. The experiment of manufacturing brick has proved a signal failure, and should those brick be used in the construction of the building, the indignation of the tax-payers would be great. As we have before said, Mr. Livingston has every inducement to build a court house well worth the money; for, as a young man whose interests are identified with the county, a failure to do this, would be a perpetual monument of his disgrace. He is to be commended in attempting to patronize home industry, and to keep the money to be expended in the construction of the building as far as possible within the limits of the county, but this will not justify him in using any but good material in its construction, much less those "mud cakes" facetiously called brick. We are glad to hear that Mr. Livingston proposes to procure real brick, and hope the report is true.
