THE INSULT UNPROVOKED

ADMIRAL FLETCHER TELLS OF THE ARREST OF THE BLUEJACKETS

OFFICIAL ACCOUNT

Mexicans Willing To Apologize But Not Fire National Salute

(By Associated Press)

Washington, April 14.—Mex.—New light was thrown on the circumstances attending the arrest of the U. S. S. Dolphin's men at Tampico, by a dispatch to the navy department from Rear Admiral Fletcher made public late tonight. A statement by the department said: "Admiral Fletcher reported to the department at 3 P. M. Tuesday, that Admiral Mayo reports from Tampico that no intimation was received by him of the existence of martial law or of objection to boats taking supplies. Stewards, orderlies, etc., were going ashore when necessary. Only part of the whale boat's crew of the Dolphin were out of the boat to handle stores. The men of the boat's crew were blue-jackets, not marines."

Unwarranted Arrests. Washington April 14.—The status of the case as summed up by cabinet officers and other officials was described as follows: "Assistant Paymaster Charles C. (Opp and a boat load of bluejackets landed at Tampico last Thursday to obtain supplies. They were arrested but later discharged. In accordance with regulations in all navies of the world, Rear Admiral Mayo on considering that an unwarranted arrests had been made, and that the uniform of the American navy had been disregarded, demanded reparation in the form of a salute of 21 guns."

"The American flag, while not taken ashore, was flying at the stern of the whaleboat and all the bluejackets were in uniform. Rear Admiral Mayo allowed the Huerta commander until 6 o'clock that evening to fire a salute but later extended the time to afford the local commander an opportunity to communicate with his superior officers in Mexico City."

"A statement of apology was issued in Mexico City by General Huerta, and the officer who arrested the marines was ordered punished. This did not satisfy the United States Government and the salute was insisted on. General Huerta himself at no time agreed to comply, but an under-secretary in the Mexican foreign office did inquire of Charge O'Shaughnessy if a salute fired to the gunboat Dolphin and responded to by the American ship would be acceptable. This was emphatically rejected by the United States, and word was sent that nothing short of a public salute to the American flag would be satisfactory."

Concord, N. H., April 14.—Harry Kendall Thaw's petition for a writ of habeas corpus was granted by Judge Edgar Aldrich of the United States district court today. The court held, however, that no order would be issued for Thaw's discharge from custody until arrangements had been completed to take the case to the United States court on appeal.

HAS NO MORE FAITH IN DIVINE HEALING

SUBJECT OF MRS. ETTOR NO LONGER BELIEVES

AN ANDERSON MAN

Notwithstanding Supposed Cure At Westminster, Charles Bowie Lost Faith

From Westminster comes the remarkable tale that a citizen of that place had his sight restored to him by taking the "faith cure" administered at the Old Baptist Tabernacle in Atlanta by Mrs. Wentworth-Etter, who claims that by the "laying on of hands" she can cure all ills. Following the receipt of this information yesterday a reporter for The Intelligencer visited Charles Bowie, an Anderson man who recently took the "divine healing" in an effort to find if Mr. Bowie had been benefited. Mr. Bowie is suffering with tuberculosis and when he was seen yesterday he told the reporter that he had lost his faith in Mrs. Etter and he could not see that he had improved in any way. He believes if God had intended for Mrs. Etter to help him that this cure would have been effected at once and he says that so far he has received no benefit. He is critically ill.

About a fortnight ago Bowie went to Atlanta and appeared in the tabernacle. He was called to a chair on the rostrum by Mrs. Etter and the entire assemblage, some several hundred men, women and children, all began to shout and pray for his recovery. Mrs. Etter then "laid hands on him" until she announced that a cure had been effected. If such a cure was effected it has not yet become manifest.

However, the story of the "divine healing" done by Mrs. Etter on the Westminster man seems to be true, as the following account of the man's sight being restored is copied from the Tuscaloosa Tribune, whose editor, Mr. A. L. Gossett is attending the sessions of Piedmont Presbytery.

"Mr. D. T. Cain, of Oakway, returned from Atlanta last Friday a happy man, having had his sight restored by the faith cure in a meeting conducted in the tabernacle Baptist church by Mrs. Etter, of the Pentecostal Union, who is seventy years old."
