NOTICE. An Act to Regulate the operation of traction engines on or across public bridges of Anderson County. Section 1. Operation of traction engines across public bridges in Anderson county, regulated. Be it enacted by the General Assembly of the State of South Carolina, that from and after the passage of this act, any person, firm or corporation, using or causing to be used, any traction engine or engines, oil or across the bridges on the public highways in Anderson County, shall in crossing any of the said bridges, place upon the surface of said bridge pieces of timber not less than two inches thick and twelve inches wide, on which said timbers the said engines may pass and cross the said bridges.

Atlanta, June 2.—"It would be a sorry day for the United States if it ever adopted government ownership of railroads," declared United States Senator W. S. "Senator West's words are of particular importance, because as a student and scholar as well as a man in public life he has studied the actual results of government ownership as practiced in the European countries and consequently is able to back up his opinions with facts."

If any person shall willfully destroy, injure, or in any manner hurt, damage, impair or obstruct any of the public highways, or any part thereof, or any bridge, culvert, drain, ditch, cut, way, embankment, wall, tollgate, tollhouse, or other erections belonging thereto, or any part thereof, the person so offending shall upon conviction thereof, be imprisoned not more than six months, or pay a fine not exceeding five hundred dollars, or both, at the discretion of the court, and shall be further liable to pay all the expenses of repairing the same.
