NO FRAUD DISCOVERED IN ANDERSON ROLLS FEW MISTAKES WERE NOT INTENTIONAL VOTERS PLEASED County Executive Committee Will Hear Favorable Report From Club Secretaries Saturday The secretaries of the Democratic clubs in the county came to Anderson Monday and compared the club rolls with the certified copies. In nearly every instance the secretaries reported that the club roll is made up of bona fide members of the club and residents of the territory embraced by the club and that there were no outsiders on the club rolls. Furthermore, the secretaries found about a dozen names which had been duplicated through honest mistake and the voters themselves requested that the change be made. For instance, in the case of Frankville or Fox Mills, the voter might have enrolled his name on the old club roll before leaving, that he was required to vote in the new box. There all came as voluntary suggestions. Four names were reported to be in error as the subscribers had not lived in the state long enough. Their names were left on the rolls, but the parties were notified to present themselves and show cause or their names would be erased at the suggestion of the controlling committees of the clubs. In only one case were duly qualified persons refused the right to enroll and that was through the inactivity of the club secretary who reported the matter himself and the two men's names were authorized to be enrolled, as they had applied for the right in due time and had not been allowed to enroll. Secretary Leon L. Rice said last night that he believes there is absolutely no fraud in the enrollment, and he believes that every person has had the opportunity to enroll. The executive committee has been called to meet on the 16th to pass upon the matters referred to above. It will convene in the court house at noon. The lists of managers of election is published elsewhere. The committee has found that there are, out of the more than 5,500 names, only between 60 and 70 who signed their initials. However, as they were honest in signing the rolls, it will be recommended to the committee by the chairman, S. Dean Pearman, that these men be allowed to vote provided that these initials fully identify the voter. It may be recommended that the votes of these men be placed in envelopes, to be counted separately. If this is constitutional, this would protect the entire box from being thrown out by the State executive committee in case of any contest. The county chairman wishes to have every man in the county permitted to exercise the right to vote, but not to jeopardize the vote of his entire precinct by voting irregularly. ATTEMPT MADE TO MURDER MAN Miscreant Hiding in Jesse Duckworth's Barn Shot at Him Three Times Sunday Jesse Duckworth, a well known Anderson county farmer, had a narrow escape last Sunday night from being killed when some unknown white man fired at him three times. The attack was entirely unlooked for and by the time Mr. Duckworth succeeded in drawing his pistol and returning the fire his assailant had made a get-away. According to Mr. Duckworth's story of the happening, he drove a horse to his home, eight miles north of Anderson, Sunday night, arriving there shortly after 11 o'clock. He entered the stable and as he did so he saw a man step out into the hall-way of the barn. Without a word of warning the man fired a pistol. The first bullet struck Mr. Duckworth's coat, passed on through his shirt and out the other side of his coat. He was so annoyed and a second later the man finished him by firing at him again. This bullet also penetrated Mr. Duckworth's coat but did not graze his body. By that time Mr. Duckworth had gotten his own pistol out of his pocket and he began to fire, shooting at the fleeing man four times. The assailant jumped a fence and escaped. Mr. Duckworth followed him and found his trail but as he was on the point of telephoning Anderson for a look-out, a hard rain began to fall. Mr. Duckworth says that he has no idea of who the man was, other than that he knew him to be white. He said that as the man would fire each time the flash of the powder from the pistol would light up his countenance and he could say that his face was white. Either the man was in the barn with a view to stealing a horse or he went there because of personal malice against Mr. Duckworth and in an effort to take his life. The latter would seem to be the more plausible explanation, since Mr. Duckworth's brother had just been to the barn less than 15 minutes before the shooting took place and he noted nothing out of the ordinary. The name has been placed in the hands of the officers and it is believed that the miscreant may be arrested.
