## SPORTS

Chicago, Jan. 22—The decisive battle of the baseball war of 1914 may be fought in a Federal court. This was intimated by persons close to the promoters of the Federal League who served notice that they would fight any attempt of clubs in organized ball to sign their players. The legality of the reserve clause in the contracts of national and American leagues will be the point over which the battle will rage, but when or where the contest will start was not made public. After delivering a challenge to organized ball, declaring the Federal League would "protect" its players and their contracts, President Gilmore of the new organization, today disappeared. The announcement of the signing of Killifer and Brennan of the Philadelphia Nationals was made soon after Gilmore had warned the Quaker City club that the Nationals would fight if Killifer and Brennan were signed, that it looked to the Gilmore cohorts like the formal picking up of the gauntlet.

Cincinnati, Jan. 22—Chairman August Herrmann, of the National Baseball commission, commenting on the telegram sent by President Gilmore, of the Federal League, to President Baker of the Philadelphia Nationals, said: "Mr. Gilmore, the Federal League and the general baseball commission can rest assured that organized baseball as well as the Federal League will protect its contract in and out of the civil courts. "Whenever the Federal League established a legal right to any ball players, there will be no interference on the part of those connected with organized baseball. The game is open to all."

In the Courts.  
Chicago, Jan. 22—The Federal League today notified organized baseball that the signing of players already under contract with the Nationals would be fought in the courts. This ultimatum was in the form of a telegram which President Gilmore, of the Federal League, sent to President Baker, of the Philadelphia Nationals, declaring he would "protect" the contracts signed by Ad Brennan and Killifer. The telegram read: "We hereby officially notify you that Ad Brennan and William Killifer have signed contracts with Chicago Nationals and have received advance money. Both our players and their contracts will be 'protected.' The Players' Fraternity will not retain on its membership rolls any who break a contract according to Otto Knabe, manager of the Baltimore Federate, who arrived here today.

Fair Warning.  
New York, Jan. 22—President Edward Barrow, of the International League, said today that the few players of the league who have jumped to the Federal League will have until the opening of the season to consider their action. After that date they will be eliminated as far as the International League is concerned, he said. "The International League will not make any attempt at retaliation so long as competition is fair, above board and on its merits."

Some Drops Out.  
Knoxville, Tenn., Jan. 21—Rome, Ga., has been dropped and Pineville, Ky., added to the Appalachian baseball league circuit, at the annual meeting here tonight. The change in circuit was made at the request of the Rome club which desired to enter the Georgia-Alabama League. The franchise of the Rome team and nine of the Rome players were transferred to Pineville. President F. B. Fisher, of the league, was re-elected. A schedule committee was appointed.

The Lajoie Decision.  
Philadelphia, Jan. 22—William Killifer the catcher who was reported to have signed with the Federal League, has signed a three year contract with the Philadelphia National League club, according to the following statement given out this afternoon by President Baker of the local organization. "Killifer signed his contract for three years with the Philadelphia Nationals yesterday, having consulted his lawyer and also his father, who is a probate judge in Michigan," said Baker. "He was advised that the Lajoie decision covered his case exactly, and that the Philadelphia Nationals had prior claim to his services and when this was pointed out to him without any further consideration he signed his contract and returned to the Nationals the advance money."

"My opinion is that if all the national league players who contemplate signing with the Federal League, or have already signed—will examine the exact meaning of their contracts, the little old joker will be found nestling away there."
