The People-Sentinel is not questioning the accuracy of the recent cotton crop estimates of the U. S. Department of Agriculture, which have caused a loss of millions of dollars to the Southern farmers, but we do question the necessity for these frequent official guesses which benefit nobody except the speculators and those who want to get the South's chief money crop year after year at less than the cost of production. And no less a writer than Arthur Brisbane, the highest paid editorial writer in the United States, concurs in this opinion. As Mr. Brisbane aptly sums up the situation, these large crop estimates merely serve to put foreign and domestic buyers on notice that a large crop has been made and they can get it at greatly reduced prices by holding off in making their purchases. On the other hand, as we State of South Carolina, have seen demonstrated during the past few months, if the Department issues a report that is favorable to Judge. an advance in prices and would, therefore tend to benefit the producer, Wall Street refuses to believe in its accuracy and depresses the market.

It seems to be absurd to say that the price is governed wholly by the law of supply and demand. In spite of a brisk demand this fall on the part of the mills, cotton has declined steadily in price, there being a difference of more than \$30 a bale between the high and low levels. We do not believe that this drastic decline in the price of the raw material has been reflected in the prices for the finished product.

As Mr. Brisbane points out, the government does not make semimonthly estimates of steel production or dabble along that line with other industries. Of course not. The producers wouldn't stand for it a minute. Then why persist in a practice that works havoc with the cotton growing industry? If estimates are a necessary evil attendant upon the production of cotton, let's make them as few and far between as possible. For our part, we wouldn't object to seeing them abolished altogether.


