March 1st, 1938, three per cent. will be added.

April 1st to April 15th, 1938, seven per cent. will be added.

Executions will be placed in the hands of the Sheriff for collection after April 15th, 1938.

When writing for amount of taxes, be sure and give school district if property is in more than one school district.

All personal checks given for taxes will be subject to collection.


