# The Japanese Bombardment of

Vladivostok. Vladivostok, March 6. -A fleet of five Japanese battle ships and two cruisers appeared off this place at 12.25 o'clock this

town and shore batteries for forty five minutes.

The fleet approached from the direction of Askold island, at the first entrance of Ussuri Bay, and about 35 miles south east of Vladivostok. Entering Ussuri Bay the enemy formed in line of battle, but did not approach to a closer range than five and onethird miles. They directed their fire against the shore batteries and the town, but no damage resulted, and most of their two hundred lyddite shells failed to explode.

The Russian batteries commanded by Gens. Veronetz and Artamonoff, did not reply, awaiting a closer approach of the enemy.

The Japanese fire ceased at 2.20, and the enemy retired in the direction of Askold Island, simultaneously two torpedo boat destroyers appeared near Askold Island and two more near Cape Maidel. The Japanese ships were covered with ice.

The attack resulted in no loss to the Russians, but cost the enemy 200,000 rubles (\$100,000) in ammunition. Most of the projectiles were six and twelveinch shells.
