THE NEWBERRY MEMBERS. From the News and Courier. The Rev. J. A. Slight, the new Senator from Newberry, was born in Newberry County on December 12, 1835. He was a student at the Academy at Lexington, and afterwards at Newberry College.

The report of the Superintendent of the city graded schools of Columbia, contains much valuable information on the subject of graded schools. The schools were run for seven months as free schools, the State appropriation being supplemented by a local levy of one mill on the property in the city of Columbia.

The total cost of tuition for the 1,493 children enrolled in our schools was \$7,145.45 for seven months, or \$1,020.78 for one month, and for nine months or a full school year's tuition at the same rates, \$9,187.02. Under any other system of educating that number of children the cost to the people of Columbia would have been at least \$26,217.00.
