



Therefore, in pursuance of secution 3700 of the revised statutes, the details of an arrangement have this day been concluded with parties abundantly able to fulfill their undertaking, whereby bonds of the United States authorized under the act of July 14. 1875, payable in coin, thirty years after their date with interest at the rate of 4 per cent per annum to the amount of little less than sixty-two millions and four hundred thousand dollars, and to be issued for the purchase of gold coin amounting to a sum slightly in excess of sixty-five millions of the United in States, which sum, added to the gold now held in our reserve, will so restore to something more than one hundred millions of dollars. Such premium is to be allowed to the government upon the bonds as to fix the rate of interest upon the amount of gold realized at the rate of three and three-fourths per cent per annum.

At least one half of the gold to be obtained is to be supplied from abroad, which is a very important and favor-able feature of the transaction.
