# Law school names ethics professorship

Despite criticism from Republicans, Secretary of State John T. Campbell on Tuesday said he was honored the USC School of Law named a professorship in ethics in his name.

The law school agreed to name the chair after Campbell when he gave the school \$125,000 the secretary of state's office received in a class action lawsuit settlement with a New York investment firm.

Republicans find much irony in the decision to name a chair after Campbell, a Democrat seeking re-election in November who has come under fire in recent weeks for lax enforcement of lobbyist regulations and soliciting campaign contributions from lobbyists.

"When it comes to ethics," said Tony Denny, executive director of the state Republican Party,

"the only chair you should name after John T. Campbell is the Lazy Boy.

Campbell said he was honored the school would name a chair after him. As for Denny's remark, "I consider the source," Campbell said.

Lawmakers have criticized Campbell for soliciting campaign contributions from lobbvists while not taking action against them for filing incomplete disclosure forms with his office. One fund-raising letter on Campbell's behalf sought \$1,000 contributions from lobbyists.

Campbell has said the contributions he receives from lobbyists do not influence his official actions. He also has said he does not have enough staff to make lobbyists comply with the law.

The \$125,000 to pay for the professorship comes from settlement of a class action suit

against Drexel Burnham Lambert Inc., the New York investment firm. The firm settled with South Carolina and 40 other states after pleading guilty to six counts of securities fraud.


Drexel agreed to pay \$650 million in penalties - \$300 million in fines and \$350 million in civil forfeitures. As part of the agreement, Drexel paid the states a total of \$8 million. South Carolina's share was \$125,000.

The money was paid to Campbell's office. which is the state's securities regulation agency. The lawsuit was brought on behalf of that office.

John Montgomery, law school dean, said he helped decide to name the professorship the John T. Campbell Chair of Corporate and Business Ethics.
