# Leaders face top issues

## Projects include safety, recycling

Recycling, safety, parking and academics seem to be the primary issues on student government's agenda this year.

Student government held the Lightways Safety Walk Tuesday, with the purpose to acquaint members of the university community with safety features of the USC campus.

It will also help "to distinguish both safe and dangerous areas on campus, to create an awareness regarding safety issues and to afford students and staff the opportunity to come together for a common meaningful cause," said Student Vice President Shine Brooks.

The walk was one of many projects Student Government has been working on since the new administration took office in February.

"We're working on many things right now," said Student President Manish Shrivastava. "They include recycling, parking, and academic issues."

Currently, Special Projects Director Debbie Drucker is calling all faculty and staff offices about recycling.

"After we talk to all the offices, we're going to compile a list of all the offices that recycle," Drucker said. "We want people to know where recycling is taking place."

"If they don't have a recycling program, we told them how they could get in touch with the Office of Recycling," she said.

Shrivastava said he is working on a letter to the

University Parking Committee concerning the Gibbs parking lot and the Carolina Coliseum lot.

"It's a letter proposing that students can park at the coliseum lot during coliseum events for no extra charge," he said.

Students are currently charged three dollars to park at the coliseum during events. The Gibbs lot, across the street from the Coliseum, is free, but according to Shrivastava is "not very safe."

Most senate legislation is in committee right now, Brooks said.

"We got a lot done early," he said. "If anything is done in Student Government, it will be this semester."

The Senate Academic Affairs Committee is working on extending the drop/add date and advisement.

"We'd like to see it (drop/add date) extended one day," said Kim Lovelace, committee chairperson.

"We're sending out letters to other schools similar in size and mission statement about their drop/add date."

Presently, the drop/add date is the first Friday of classes.

"With the current date, students many times will not have a good idea about their classes," she said. "Usually, not much happens in the first class period."

Lovelace said the committee has temporarily put aside work with the withdraw date and grade forgiveness.

The withdraw date is before the midway point of the semester right now. In many classes, professors do not give their first exam until after the withdraw date, violating a code in the faculty handbook.

One of Brooks' campaign pledges concerned the extension of the withdraw date.

The advisement critique form is almost complete, and will be ready for distribution very soon, Shrivastava said. The form is an innovation Shrivastava has worked on extensively this year.

# Holderman troubles continue

investigated on his own but could find no solid evidence.

"I could not come up with anything I would consider factual enough to risk ruining a man's reputation," he said. "Had I had any hard information, I believe I would have contacted the chairman of the board."

Trustee Mark Buyck said he heard rumors since Holderman resigned from USC in 1990, but not before. "I never heard anything that I thought was substantial," Buyck said.

Several professors and at least one USC trustee did hear allegations that Holderman made sexual advances to students, but the charges were never investigated, the *Observer* reported.

Meanwhile, Trustee Chairman Michael Mungo has threatened the jobs of any university officials who knew about Holderman's advances to male students, but did nothing about them.

Mungo was out of his office all day Tuesday, and messages were not returned.

Trustee Othniel Wienges, chairman of the board while the advances were said to have taken place, has been away from his St. Matthews home this week.

not believe it would be appropriate for you to return to the University of South Carolina in a teaching or administrative capacity," Palms said.

"I have continued to consider the facts and circumstances which form the basis of my opinion and have concluded that it is not in the University's, or the University faculty's, best interest for you to continue to be a part of the University faculty."

"Therefore, I write to inform you that I believe it incumbent upon me to commence tenure revocation proceedings in accordance with the provisions of the University's Faculty manual," Palms said.

Palms went on to tell Holderman he would "postpone notifying the appropriate University committee of my decision until December 1, 1991."

Palms' letter was written two days before *The Charlotte Observer* published the students' claims. An anonymous source, who was aware the article would come out Sunday, told *The Gamecock* he called Palms' office Friday and informed the office the article would be published.

Cindy Oswald, from the President's Office, confirmed an anonymous caller did call the office Friday.

"There was great concern, however, that the caller was one of the students who made a claim in the article," Oswald said.

The caller told *The Gamecock* he did not make any claims within the *Observer's* article.

The only appropriate ground for tenure revocation applicable to Holderman is "misconduct related directly and substantially to the fitness of the faculty member in his professional capacity."

Palms must recommend tenure revocation to the Faculty Advisory Committee.

The new Portfolio submissions deadline will be November 1.
