Human rights violated

KHARTOUM, Sudan - Three years ago, a military coup put Lt. Gen. Omar Hassan el-Bashir in control of Sudan, Africa's largest country and one of the world's poorest. He turned the multi-religious country into an Islamic state and has pushed to overhaul the economy and crush a now 9-yearold rebellion.

In doing so, Sudan's government has flagrantly violated human

"The situation for human rights is extremely serious," the Londonbased Amnesty International said.

"Anyone who is non-Muslim is a second-class citizen," said the Rev. Roger Schrock of the New Sudan Council of Churches, based in Nairobi, Kenya.

The main conflict in the nation of 28 million has been between the Arab Muslim majority government in the north and the southern rebels, who are mainly Christians and animists of African descent.



They had lived in this small town for about four years, neigh-


Scruggs was seen Tuesday morning at his mailbox about 100 yards from the home.

Mars Observer lift off

PASADENA, Calif. - When McIntosh: "no contest" NASA's Mars Observer spacecraft blasts off Friday, it will follow a path marked by numerous fiascos and some stunning successes in the 32 years of superpower attempts to reach the Red Planet.

"Sure, I'm going to be nervous," Bevan French, scientist in charge of the \$891 million Mars Observer program at NASA, said. "We're all going to be nervous. But panicky or worried? No."

Mars Observer is scheduled to lift off from Cape Canaveral, Fla. It will be the first U.S. spaceship sent toward Mars since Viking 1 and 2 in 1975, and the first Mars mission by any nation since the Soviet Union launched two Phobos spacecraft in 1988 and lost contact with

Tropical Storm Danielle was marking time off the East Coast Thursday, but could reach North Carolina in a day or two.


