# Meeting requirements key to obtaining in-state residency

burden of proof. Such persons should provide to the designating residency official any and all evidence which the person believes satisfies the burden of proof."

An "independent person" is defined as: "One in his/her majority (eighteen years or older), whose predominant source of income is his/her own earnings or income from employment, investments, or payments for trusts, grants, scholarships, loans or payments made in accordance with court order. An independent person must provide more than half of his or her support during the 12 months immediately prior to the

date classes begin for the semester for which resident status is requested and cannot be claimed as a dependent or exemption on the federal tax return of his or her parent, spouse or guardian for the year in which resident status is requested.

Once a student does qualify as independent, he or she is asked to provide certain "indicia as listed below. The absence of these indicia in other states or countries is required before the student is eligible to pay in-state rates.

 statement of full-time employment; possession of a valid South Carolina voter registration card and voting in South Carolina elections;

 designating South Carolina as state of legal residence on military record;

 possession of a valid South Carolina driver's license, or if a non-driver, a South Carolina identification card;

· possession of a valid South Carolina vehicle registration card;

• continuous presence in South Carolina during periods when not enrolled as a student;

· paying South Carolina income taxes as a resident during the past tax year. including income earned outside of South Carolina from the date South Carolina domicile was claimed;

•ownership of principal residence in South Carolina;

 licensing for professional practice (if applicable) in South Carolina."

An interesting stipulation falls under the codes for marriage, where the codes states, 'If a non-resident marries a South Carolina resident, the non-resident does not automatically acquire South Carolina resident status. The non-resident may acquire South Carolina resident status if the South Carolina resident is an independent person and the non-resident is a dependent of the South Carolina resident.'

## Beasley's pro-family agenda causes tension with health agencies

"The question is whether it's an appropriate use of tax dollars, and whether it sends the kind of message we want to send," Karr said. "The program needs to have enough controls on it that it encourages the kinds of things the governor wants to encourage, like limiting sex to married couples and discouraging teenage sex and discouraging unhealthy behavior. He didn't do this in an attempt to curry favor with one group or another or make one group or another angry."

Karr said the governor is concerned about losing Title 10 funds, but he is not willing to enact "bad policy" because there is money attached. He said the governor wants to emphasize his philosophy that teens and unmarried adults should abstain from sex.

"This is not an attack on family planning," he said. "This is not an attack on methods of contraception that are widely available and are

harder for people with limited financial means to purchase. The governor has concerns about whether handing out condoms, especially to teens, encourages them to engage in behavior that is not appropriate and not healthy."

Karr said teen pregnancy and STD rates rose during the 20-year period DHEC distributed free condoms, so suspending the program should not have a dramatic effect. Karr said DHEC could reach a

decision as early as this week. He

### Department of Philosophy plans seminar


