Open positions in search process

The search is beginning for a new Associate Provost and Dean of the Graduate School, and Chair of the Department of Civil and Environmental Engineering at USC.

Applications for the Associate Provost and Dean of the Graduate School will be reviewed starting June 16.

The search committee hopes to have an replacement by July 1.

Applications for Chair of the Department of Environmental and Civil Engineering are being now being accepted.

Both positions will be filled by someone from within the university.

The responsibilities for Associate Provost and Dean of the Graduate School include teaching, creating policies for the school, graduate admissions and coordinating interaction with other state agencies.

To be eligible for the position, a candidate needs to have tenure, demonstrated commitment to academic excellence in graduate education, professional integrity and high ethical standards, a record of successful interaction with faculty governance and strong organizational skills.

Candidates interested in filling the position will remain confidential unless recommended for the position.

Interested applicants should submit an application letter, resume, a brief statement of personal views of graduate education and 3 to 5 references.

Applicants interested in the Department Chair of Civil and Environmental Engineering must possess an earned doctorate, be a full professor, have experience with sponsored research and scholarship.

The reviewing process begins immediately.

Interested applicants should submit a letter of interest and application, including a curriculum resume and three references.

Other job openings on campus include undergraduate assistants, graduate assistants and office administrative assistants.
