## Clinton Blood Program Successful

A total of 384 pints of blood have been donated by Clinton employees as the company participated in the Carolina Blood Center's Blood assurance program.

According to Sonny King, co-ordinator of the company program, all Clinton (SC) plants employees have been offered an opportunity to donate except Plant No. 1 & 2 second shift. These have been scheduled for January of 1981.

"It is important for those potential donors who were turned down to remember that in most instances, they were just temporarily deferred. Employees with minor illnesses such as colds, sore throat, cold sores, etc. can be potential donors when the Blood Center's mobile team visits the plants next year."

## Savings Checks Exceed \$674,000

A total of 711 thrifty Clinton Mills employees received Christmas Savings totaling \$674,803.20 as employees received their savings checks on November 14, 1980.

Numerous hourly paid employees had savings checks exceeding \$5,000 with the highest being in excess of \$5,500.

To begin collections for the 1981 Christmas savings account, an employee must sign an authorization card available from his/her Assistant Departmental Superintendent.

Anyone may start, stop, or change an account at anytime during the year. However, once a withdrawal is made from a Christmas Savings Account, another account cannot be opened during that particular Christmas Savings Account year.

Completed accounts earn interest at the rate of 5 1/4% per annum. The 1981 accounts will not be due or payable until December, 1981.

## Closing Dates

In observance of Thanksgiving Day, all plants will close at 12:00 midnight, Wednesday, November 26, 1980, at the end of the regular second shift, and will resume operations at 12:00 midnight Thursday, November 27, 1980, with the regular third shift.

In accordance with the Paid Holiday Policy, Thanksgiving Day will be a holiday with pay for all eligible employees.

Clinton employees enjoy seven paid holidays annually. Among these are, in addition to Thanksgiving Day, Christmas Day, New Year's Day, Easter Monday, Memorial Day, July 4, and Labor Day.
