Dispensary Legislation.

Temperance people will be pleased that the Legislature refused to enact any law looking to the restoration of the license system of

selling liquor in this State. The idea of high license, as far as this town is concerned, is an exploded theory in so far as its power for good is concerned. Abbeville tried high license years ago, and it just won't do.

There are various objections to high license, fair play, and every believer in equal rights to all must oppose so iniquitous a measure.

First-High license creates a monopoly, and growds out the poor man, who may be unable to pay the high license, though he may be, in other respects, a better and a more conscientious man than the rich neighbor who is able to pay for a "high" license. No man who favors equal rights to all, can well afford to advocate a monopoly whereby the rich may become richer, while the poor man is driven out of business.

Second-The favoritism which "high" license gives to the rich by denying license to the man of less money, must be offensive to our sense of justice, and can only be regarded as legislation against the poor man to give the rich man a monopoly.

Third-High license, as well as low license, must be contrary to the convictions of those who oppose the liquor method of corrupting our people, and leading our youths into devicus ways.

Fourth-Under the dispensary law, we have absolute prohibition for about twelve hours in every twenty-four hours. On Sunday the dispensary is never open. It may be remembered that under the bar-room system, the places where liquor was sold, was often kept open at night, and sometimes on Sunday men could get liquor.

Fifth-The idea that the legislature tried to forbid, or prevent the people from voting on the question of opening the bars is fallacious. In 1892 the temperance people asked the Democratic Executive Committee to place boxes at the polling places where the voters could express their preference for prohibition or The prohibitionists carried the State by about 10,000 majority. In response to the expressed will of the people, the legislature gave us the dispensary, which was possibly intended as a compromise between license and prohibition.

Sixth-The dispensary having wrought a great revolution, the whiskey interests seem to be combined to break up the best liquor law that we ever had, and it is a lamentable fact that some well meaning people have joined the enemy in their effort to restore the whiskey license in this State.

Seventh-In view of the trade whereby it was sought to deliver the temperance people per man. He has written much of the people into the hands of the liquor people, and in the face of the fact that the leader of the prohibition campaign, after the election, openly declared himself in favor of local option, and in acknowledgment of the further fact that some of the advocates of the license system, having manifested extraordinary and uncommon zeal for the restoration of the license system, the public are unable to understand the origin of the wonderful influence that has brought about the notable and remarkable things.

Eighth-If the people, or the advocates of either the high license monopoly plan, or the old Democratic plan of a reasonable license work to get an expression of the people on the subject, they can do as the prohibitionists did, get the co-operation of the Democratic Executive Committee in placing a separate box for that purpose.

FREE RURAL DELIVERY.

Some of Congressman Latimer's Good

Work. Representative Latimer is one of the few Southern Congressmen who has succeeded in getting the Post Office Department to use his District as a place for trying the free rural de-livery of mail. The department, under the

getting the rost once Department to use his District as a place for trying the free rural delivery of mail. The department, under the direction of Congress, has been experimenting for a year or two with the subject of the free delivery daily of mail in country communities, but the small appropriation made for the purpose (about \$150,000 a year) has been chiefly expended in other sections of the country. The department has at last consented for Mr. Latimer to name six places within this Congressional District at which such service shall be established; and we understand that he will name Abbeville, Greenwood, Prosperity, Anderson, Easley and Walhalla as the points, and that the service will probably cover the country embraced within a radius of five miles of the points named. The carrier will be required to travel at least twenty miles a day in his rounds, and receive for his service a salary of \$400 a year.

If the appropriation available for this service were divided equally among the Congressional Districts of the country, there would be about \$600 to be expended in each District.
