The bones were discovered by children and taken by Mr. Edmunds to the city, where an examination was made by medical men. 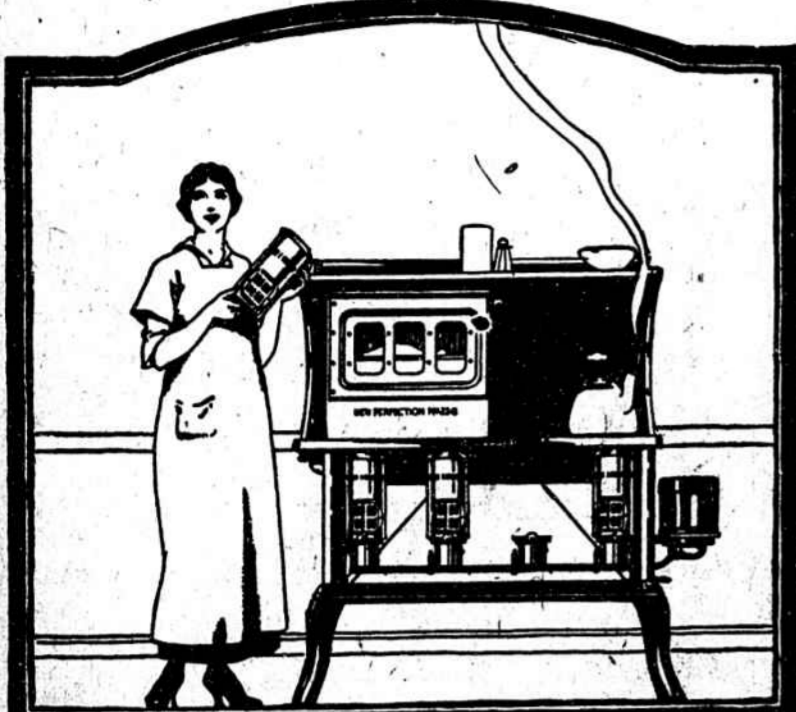
