

Mr. Treadway said the latest report of the comptroller of the currency "shows that the amount of exchanges of clearing houses of the United States for the year 1919 was \$387,091,000."

"Assuming that 25 per cent of the transactions of the country did not go through clearing houses," Mr. Treadway's statement said, "there should be added to this amount \$96,772,985,000, making


