

GALLOWAY GETS PLACE IN ALL-STAR AMERICAN

Chick is Voted Best Shortstop By All the Umpires

Chick Galloway has been selected as shortstop in the All-Star American League Team. All the umpires seemed agreed that Galloway was the most improved ball player in the American League.

When asked how it felt to be a star, Chick's eyes flashed and some very white teeth appeared as he said with a smile, "It's great."

You should know this Chick Galloway when he is home, and home is Abbeville, South Carolina with Mrs. His real name is Clarence Edward Galloway, son of Mr. and Mrs. A. K. Galloway, twenty-five years old and a fine manly looking fellow, of quiet manner and address.

He was born at Manning, S. C., the family later moving to Clinton and then to Abbeville. At Clinton he attended the public school and the Presbyterian College at which institution he became interested in athletics. Three years he was letter man in the Major Sports football, basket ball and baseball.

Galloway was recognized as a good ball player in college. His first engagement was with the Atlanta Southern League in 1919. In the fall of that year he went with the Philadelphia and has been with them ever since.

Chick couldn't be persuaded to talk about himself. He says he has no hobbies, no pets, doesn't smoke, drink or chew—but just "plays ball." But when asked about the athletics he warmed up and there was an eager light in his eye, and this is the story.

The Athletics played 154 games this season and about 50 additional exhibition and training games. Of this number Galloway played every game and that is some record and speaks for itself.

He thinks it would interest the people to know that the majority of the ball players are college men and they are going in stronger each year. They are all nice, clean fellows. He expects the Philadelphia Athletics to come out much better next year than they did the present year. He thinks the team will be stronger because the pitching will be better. With the additional fielders the outfield will be stronger and also the infield.

Training will begin about the first of March in Montgomery, Ala., and will last about five or six weeks. The Athletics carry 25 men on the team and of this number 8 or 9 are pitchers.

Abbeville is proud of this son who has won a place for himself in the greatest of all sports. And it is only natural for the people here to feel a thrill when he becomes a "Headliner" and to bask in the sunshine of his reflected glory.

Galloway has three brothers who give promise of coming into the limelight later on. Eugene Galloway is attending the Presbyterian College at Clinton, Bruce Galloway is a student at Furman University at Greenville and Ashby Galloway is attending the Abbeville High school and last but not least, is an adoring mother and father.

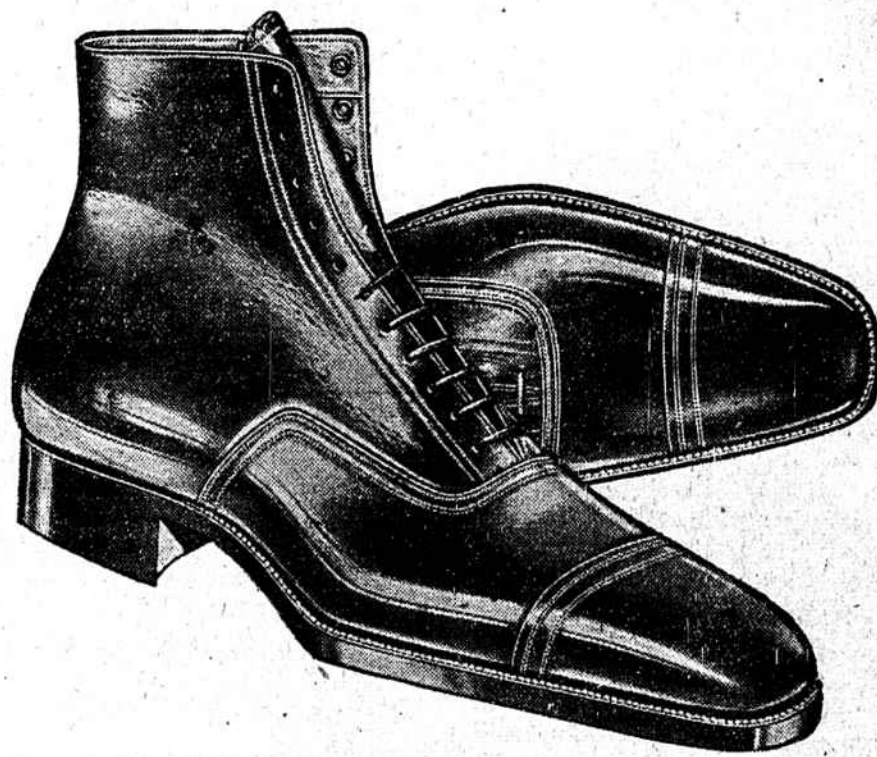
