CUTHBERT, Randolph Co. (Ga.,) Sept. 7.
The Cotton Crop—1 have never heard such universal complaints in all my life, as greeted me from every quarter upon my return home from your city. I met many planters in Stew-art county on Tuesday, and in no instance did I meet with a single man who did not think that such had been the injury his crop had sustained by the present drought, the cold weather of last week and the destructive bowl worm, that his crop would fall short of last year. Upon my return home, I found the same complaint among the planters of Randolph. There is another casuality, still more destructive. The caterpillar has made its appearance, and is de-vouring the plant all south of us. They ap-peared in my farm on the River last week, and had pretty much eat up every leaf by Tuesday. My overseer came up to see me about it, he says they will certainly cut off my crop from 30 to 50 bales. (I expected to make 100.) and that the plantations below have been destroyed for a week. I believe the opinion is almost universal that the crops of '44 in this region will fall considerably short of that of '43. The caterpillar has appeared three weeks sooner than they did last year, and of course the rava-ges must be more extensive than last year.

NEW ORLEANS, Sept. 4. We have experienced a fair demand for Coton since our last, and the market was freely supplied until to day, when holders displayed more, firmness. The bulk of the business, which comprises 2,200 bales, was taken by a Mexican buyer, and the remainder for England, France and Spain. The receipts are coming in freely, and the weather continues very favorable to the crop.
