His body was recovered and the Coroner's inquest had no hesitation, upon the very strong testimony submitted to them, to bring and instant verdict of "insanity." Thus has perished a young clergyman, whose pulpit performances had given high evidence of intellectual power, and whose blamelessness of life had won him many friends in the

The principal features of the new post

age law are as follows

1. Single letters, i. e. letters weighing half an ounce or less, go 300 mile for five and greater distances for ten cents. Every additional half ounce (or part of a half an ounce] is considered an additional letter.

2. Newspapers may be sent by the pub lishers thirty miles from the place of publication free of postage .- For greater distances the rates are as heretofore.

3. Printed circulars on cap or letter paper are charged two cents a sheet for all distances.

4, Pamphlets, magazines, &c., two and a half cents for each copy sent of no greater weight than one ounce: and one cent additional ounce.-But ao copy exceeding eight ounces in weight can be transmitted No bound books of any size can be sent by mail. 5. Members of Congress can frank let-

ters, &c., as much as they please, both in session and recess, provided the package does not exceed two ounces.

6. Private mail expresses forbidden on heavy penalties. Persons sending letters by an unlawful mode are made punishable. Any persons who shall deposite a letter at any place to be carried by unlawful means is subject to a fine of fifty dollars for every offence.

Two New Manufactories have been chartered in Massachusetts and are to be erected in Newburyport. One is to have a capital of \$150,000, and half the stock has been taken in Boston. The design is to manufacture heavy drillings of the descriptions which have been so successfully exported to foreign countries. It has been stated that such is the cheap and superior character of the article compared to the English manufacture, that it has been used for clothing the British army in India.

Melancholy.—Mr. W. J. M. Wimbish, of Pontotoc, Miss. was recently drowned near Memphis Tenn., under the following circumstances. He and a friend were at Memphis when the steamhoat Belle of the West landed at the wharf late in the evening. They, imagining the vessel intending to lie there during the night went on board. Shortly afterwards the Belle of the West got under way. They besought the captain to put them ashore, which he refused to do until persuaded therto by some of his passengers, when he agreed to put them out at a wood yard ten miles above the city. The yawl was let down and the parties, with two sailors got in. The steamboat was under such headway at the time that the yawl capsized. The two sailors got to the shore, but Mr. Wimbish was drowned. There are many gratifying facts developed in the late news from England, touchng the relations of that country with this. The policy of Great Britain begins to wear very visibly the impress of an American influence. The reduction of the duties on Cotton, and the discrimination in favor of the Sugar raised in the United States over that produced elsewhere by slave labor, imports much; and the speeches in and out of Parliament, urging still further reductions in the duties on the agricultural products of this country, which, even under the existing tariff, flow in England in the adoption, as the settled system of England, of that which the Democracy of the United States has urged as the only true financial and commercial principles, viz: trade unfettered by any other than a strictly revenue tariff. The doctrine of protection for monopoly is alike abhorrent to the masses of both countries; and the effect of this feeling is evidently reaching both Go-

THE COTTON TRADE.

Extract of a Liverpool Circular, duted Feb. 28th. The announcement of the Minister on the opening of the Session that he would bring forward his financial measures at so early a period as the 14th Feb., caused much excitement and speculation as to the contemplated changes, these are now known, and we refer to the public papers for them. On the whole they give much satisfaction, although there are complaints from those whose interests will suffer; this, however, is unavoidable. It will be observed that the duties on no less than 430 articles are wholly repealed, but with the exception of a few, the impost on them is of so trifling a description as to be practically of small importance.

· The reduction of the duty ou Sugar is the most important of the changes; it inight have been wished that the new duies were less complex and embraced all kinds of Sugar wherever produced; how ever the boon to the consumer is considerable, and the consumption will no doubt be largely increased. British plantation Sugar has advanced 3s. a 4s, but Foreign Sugar remains unaffected on account of the prospect of a large supply from our own colonies. The next in importance is the repeal of the duty on Cotton, which was no less unexpected than welcome; the momentary effect will be to raise the price in the United States, but that is of little importance since the object was not to lower the cost of the article but to place the English manufacturer upon an equal footing with foreign manufacturers. The future and ultimate effect will of course be to lower the cost of Cotton by the

amount of the duty.

The remaining articles which are affected by the changes and which are of any interest to our friends in the United States are, Ashes, Bark, Beeswax, Dyewoods, Flax, Grease, Hemp, Hides, Lard, Lard Oil, Pitch, Rosin, Skins, Staves, Tar and Turpentine. Spirits or Oil of Turpentine will be admitted on a duty of 2s instead of 3s per cwt. Whale Oil is to be admitted free of duty after the 1st of January, 1847. Whalebone and Sperm Oil after the 1st January, 1849. The excise duty on Glass which prevented the improvement and extension of this branch of manufacture is to be taken off.

These measures are now progressing through the lower bouse, and it is understood that as soon as the resolutions are agreed to, the tariff will go into effect without waiting for the more tedious process of the bill passing both houses. is of much importance, because any delay in such changes has always proved very injurious to business.

THE NEWS-THE MARKETS. The New-York letters of Wednesday, P. M. published in the Philadelphia U. S.

Gazette and N. Y. American, say-The news by the Steamer Cambria is the cause of much congratulation among business. The Southern trade anticipate a sudden revival of business upon the Cotton news. Holders of Sugars are very

firm on the news. The best informed Sugar people express the opinion that very little Sugar can come to the United States, at the present rates in Europe unless our market further advances. The Sugar and Molasses market here cominues very firm. Stock are slowly diminishing under the demand from country grocers. Our markets have already felt the effect

of these advices-the sales of Cotton reach 3,000 bales, at an advance of \$ a 1 upon yesterday's prices, which were a better than at the close of last week.
