MASTER AND APPRENTICE. There are few relations which, taking them in all their bearings, are more interesting or important than of master and apprentice, whether we regard it in reference to present or the future. It is the intervening link between the dependence of childhood and the responsible condition of manhood. On its proper appreciation, and the due performances of its requisitions, must depend the ability on the part of the young, to become useful and respectable.
Without the ties of blood relationship, it embraces the responsibility of parentage on the one hand, and the deference due from youth to age on the other. In a word, it is the exercise of paternal authority on the part of the master, and the practice of filial raspect on that of the apprentice. Regarding the faithful discharge of these reciprocal duties as a matter of essential consequence, it has been with no little regret that we have seen in this country the frequent subversion of the true intent of this institu-Instead of looking upon the person to

whom he binds out his child, as the depository for the time being of his own authority, the American parent too frequently regards him as a hard task master, to whom nothing is due beyond an extorted and unwilling obedience. So far from encouraging his offspring to yield affectionate and ready compliance with the wishes of his employer, the father, in many cases, inculcates the lesson that nothing more is to be done than is indispensable to secure the benefits embraced in the contract of apprenticeship. Such contract on the part of the parent very naturally induces a corresponding feeling and course of action on that of the child. His endeavor, too frequently, is to thwart the wishes of his master, whom he looks upon as one eager to extort from him every thing on the score of a service which is the offspring of a bare legal obligation. Hence it is that we see our courts of justice occupied with litigants, and in settling disputes between master and apprentice. However eager the parties may have been to enter into contract, as making a provision against want, no sooner does any little circumstance occur, which, in their opinion may operate as a release from its obligations, than the courts are annoyed with an application for a discharge from the indentures. Such, indeed, is the feeling on this subject, that parents avoid, if possible, the formality of a wruten instrument, bemuipal bond, further than the convenience of one or other party may dictate. It may be improper here to say that this notion, so generally entertained, is entirely erroneous. and that, provided a specific contract and part performance can be proved. a verbal agreement is all sufficient, the written document being nothing more than evidence, of the intention of the parties. Such we believe, is the true legal doctrine according to the decision of our tribunals, as it is certainly the conclusion at which common sense would arrive in the premises. In pursuing this unwise course, parents seem to overlook the injury they inflict upon their offspring when they inculcate insubordination to duly constituted authority. They do not reflect that the youth who is taught to disregard the commands of a master will very soon look with contempt on the authority of a parent. It is the propensity of youth to be restless under restraint, and it is of little importance to a lad whether his wishes are thwarted by a father or a master. Of the truth of this remark the strongest evidence is to be found in the fact that a bad apprentice never yet made a dutiful child. Nor does the apprentice seem to reflect

that in opposing the will of his master and indulging in a refractory spirit, he is only beaping up difficulties for himself. The relation of master and apprentice is necessarily one of limited duration. He who is learning at the present time, must in the it-any further than we have a desire to pro course of a very few years, become in his mote the health and happiness of our fellowturn the instructor, and should the evil example which he has himself shown be visited upon himself, he must not be surprised at receiving the reward for his own

Parents should recollect while they countenance the unruly spirit of their children towards their masters, that as it is the duty of the latter so it is their interest not to exact too much from their apprentices. There may be here and there an instance to the contrary, but in ninety-nine instances out of a hundred, it is believed. the disposition of masters is to be lenient with a view to their own comfort and profit. Brute force never can elicit the same exertion to please that kind of treatment always produces, and the master who treats his apprentice with wanton barshness will find uniformly that he is the loser by it.

How often do we find even moderate correction objected to on the part of parents, and yet the right to use it is indispensable to the exercise of authorty.present day noted for gross immorality and misconduct? It is not that the proper restraints have been broken down, and masters are too often absolutely afraid to do their duty by those who are committed to their care. Look into the streets, and see who are the disturbers of the public quiet-the night brawlers on the high ways. Are they not ill manuered, unruly boys? Look into the penitentiaries and jails, and who are found the inmates of them? Are they not persons who when young disregarded wholesome control. and who by the indulgence of their unbridled passions have worked out for themselves infamy and disgrace?

Introduction of Cotton into Turkey .-The Solian of Turkey, who is one of the most intelligent monarches of the age, has determined to make an effort towards the introduction of the culture of Cotton into his dominions. With this view, more than a year ago, he requested the American Minister at Constantinople to confer with the Secretary State, for the purpose of selecting and sending to him one or two Americans well acquainted with the process of cultivation of the plant.

Mr. Buchanan has at length succeeded in accomplishing the preliminary meas ures, by the appointment of Dr. J. Lawrence Smith. of this city, and Dr. James B. Davis, of Columbia, who will leave by the 1st of October at the latest, for Eng land, on their way to Constantinople .-They are to carry with them a Cotton Gin, ploughs, hoes, cotton seed of the various kinds cultivated in this country, agricultural books, and every thing else necessary to commence at once, for which the Sultan is anxious, the necessary preparations for planting next year.
