PICKENS DISTRICT, Nov. 1858. Mn. Epiron:-It is not selfishness to say that "char ity should begin at home." It would, perhaps, be no mis-nomer to call this the first principle of self-preservation. We are told in Holy Writ that he who provideth not for his own household, hath denied the faith and is worse than un infidel. Now, the people of the Southern States have a great deal to say about Northern fanaticism. And how could it be otherwise, when that pertilent thing is constantly attempting to encroach upon the most cherished rights of our section, and threatens also to break up the best Government ever devised by man? But has the South always acted wisely in regard to this sectional controversy?
