Can one blame my health for giving away—shut up, confined in prison for almost ten long months, knowing my wife and children depended on my labor for support, not knowing what would become of them, not knowing but my children were crying for bread and I shut up on a false charge and unable to help them or to go to their assistance. And my wife, to what could she be driven in her's and her children's extremity? I wonder that my health has given away and that I am a miserable wreck, waiting death to relieve my pain, misery and long suffering. God alone knows why, in my loneliness, I did not go mad.
