## The Legislature.

The General Assembly of South Carolina met in regular session yes terday in the city of Columbia and after being duly organized proceeded at once to business.

The Governor's annual message was read and his various recommendations were referred to appropriate committees.

About the only matter of general interest introduced was two bills extending the time for paying taxes without the penalty: the first bill fixes the limit to March 15; and the second to February 20.


