



assessment of taxes, (Revised Statues,) reads as tollows:

All property shall be valued for taxation at its true value in money, which in all cases not specially provided for by law, sha'l be held to be as follows, to wit: For personol property the usual selling price on the usual terms of similar property at administrator's or executors' sales, at the place where the return is made; and for real property, the usual selling price on the usual terms of similar property at sales tor partition under the order of court, at the place where the return is to be made. If there is no usual selling price, then at what is honestly believed could be obtained for the same at a fair sale under the conditions above mentioned.

It shall be the duty of each owner of lands, and of any new structures thereon which shall not have been appraised for taxation, to list the same for taxation with the County Auditor of the County in which they may be situated, on or before the twentieth day of February next, after the same shall become subject to taxation.


Section 6. That from and after the pas sage of this act, there shall be assessed upon all taxable polls in this State a tax of one dollar on each poll, the proceeds of which tax shall be applied solely to educa. tional purposes. Every male citizen be-tween the ages of twenty-one and sixty years, except those incapable of earning a support, from being maimed or from other causes, and except those who are made exempt by law, shall be deemed taxable

Ail returns for taxation must be filed with the Auditor pot laterithan February 20th, 1900, as after that date the law requires an addition of 50 per cent. to the last year's return.

Township Board of Assessors will meet at some convenient place in their respective township on Tuesday, March 6, 1900. County Board of Equasization, will meet at the Audito.'s office on Tuesday, March 27th, 1900, at 10 o'clock a. m. G. A. DERRICK.
