The Land of Flowers.

To the Editor of the Dispatch: On the morning of the 10th of De cember, at 10 o'clock, we boarded the Seaboard Air Line Railway in Co lumbia for Fort White, Fla.

Passing out of the city on the high trestle, and crossing the Congarce river over into Lexington, we moved with rapidly increasing speed through a country that looked barren and very poor.

Arriving at Denmark about 11:30, we stopped for about a minute. From thence we rolled on to Fairfax, arriving there at 12 m. After a stop of a minute, we again began moving and passed through a low marshy country which marked the approach to the Savannah river, and crossing it at 1 p. m.

We arrived in the beautiful city of Savannah at 1:40 p. m., and stopped there 9 minutes. After leaving Savannah we arrived at Jacksonville, Fla at 5 p. m., where we changed cars for Lake City, making that point at about 7 p. m. Here we had to camp for the night. The next morning we boarded the cars at 7 a. m., for Fort White, reaching that point at 9 a. m., where we were met by our family connections and took breakfast with them. We made this place our headquarters during our stay in Florids. From this place we went out over the country visiting our relatives and looking at the country, seeing many curiosities and strange things. Among the many strange things that we saw were the sinks in the ground all over the country, some of them as deep as 30 feet and some containing water while others were dry. The country is filled with salamander and gopher holes, but we never got to see one of them as they had gone into winter quarters. The storm that visited S. C. some years ago blew down all of their timber and the country is very open. The greatest curiosity that we saw was the Ectratucanee river which makes a river large enough from the head to run boats upon it. There seems to be five or six streams springing up from the bowels of the earth as large as barrels forming a river from the source head. I was told that the water at the springs was thirty feet deep and I thought I could see to the bottom. I put my hand in the water and it was as

warm as artesian water. I was told that this stream can be traced for miles through the country where it runs under the ground by the sinks in the earth, finally burst ing from the bowles of the earth and making a river from the head.

I was also told of another stream that runs on top of the ground and then goes down into the earth and then lost to sight. Florida seems to abound in these subterrenean streams. Near Lake City are many lakes that look like they cover hundreds of acres of land and of immense depth, abounding with fish of various kinds. These lakes have no inlet nor outlet. The city receives its name from them. On the cars from Jacksonville to Lake City I saw a man who was pointed out to me as the largest man in the world, weighing 750 pounds, going to Lake City to be exhibited.

There are no oranges in Columbia county, the freeze some years ago having killed all the trees.

After traveling over the country for ten days, we turned our faces homeward, boarding the cars at Fort White at 2 p. m. on the 20th day of December, reaching Columbia, S. C., on the morning of the 21st, at 4 o'clock and remaining there until 4 p. m., when we boarded the cars for Lexington, S. C.

Section 270 of the law in reference to the assessment of taxes, (Revised Statutes,) reads as follows;

All property shall be valued for taxation at is true value in money, which in all cases not specially provided for by law, shall be held to be as follows, to wit: For personal property the usual selling price on the usual terms of similar property at administrator's or executor's sales, at the place where the return is made; and for real property, the usual selling price on the usual terms of similar property at sales for parti tion under order of court, at the place where the return is made. If there is no usual selling price, then at what is honestly believed could be obtained for the same at a fair sale under the conditions above mentioned.

It shall be the duty of each owner of lands, and of any new structures thereon which shall not have been appraised for taxation, to list the same for taxation with the County Auditor of the county in which they may be situated on or before the 20th day of February next, after the same shall become subject to taxation.

Section 6. That from and after the passage of this act, there shall be assessed upon all taxable polls in this State a tax of one dellar on each poll, the proceeds of which tax shall be applied solely to educational purposes. Every male citizen between the ages of 21 and 60 years, except these incapable of earning a support, from being maimed or from other causes and except those who are made exempt by law, shall be deemed taxable polls.

All returns for taxation must be filed with the Auditor not later than February 20, 1902, as after that date the law requires an addition of 50 per cent. to the last year's return. All real estate to be assessed this
